## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On January 21, 2016, NY State of Health (NYSOH) issued a disenrollment notice, stating that your qualified health plan (QHP) coverage at full cost would end effective February 29, 2016. You appealed that notification insofar as you were seeking a termination date of January 1, 2016.

On August 12, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because NYSOH had subsequently approved your request for a QHP termination date of January 1, 2016, and you have since been refunded the premiums you paid for coverage between January 1, 2016 and February 29, 2016.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
