Dear [REDACTED],

On January 21, 2016, NY State of Health (NYSOH) issued a disenrollment notice, stating that coverage for you and your spouse under the Essential Plan would end effective February 29, 2016. This notification was issued because you and your spouse were no longer eligible to remain enrolled in the Essential Plan. You appealed that notification insofar as you were seeking reinstatement of your coverage in the Essential Plan, effective March 1, 2016.

On August 16, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because you and your spouse now have insurance coverage through your spouse's employer.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
