## **NOTICE OF DISMISSAL – FAILURE TO APPEAR**

On March 15, 2016 New York State of Health (NYSOH) issued an enrollment notice confirming that you, your spouse and children were enrolled in Medicaid (EmblemHealth) with a plan enrollment start date of April 1, 2016.

On August 10, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for August 30, 2016 at 1:00 pm.

On August 30, 2016, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you using the telephone number that you provided to NYSOH between 1:00 pm and 1:30 pm. However, there was no answer. Accordingly, we were unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NY State of Health will not review your appeal at this time.

### **If You Think Your Appeal Should Not Be Dismissed**

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and the Marketplace will take no further action on your appeal.
