NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On April 5, 2016, NY State of Health (NYSOH) issued an enrollment confirmation notice stating your two children's Medicaid Managed Care plan would begin May 1, 2016. You appealed this notice.

On October 12, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your daughter had since been enrolled in her new Medicaid Managed Care plan and had acquired the medical devices you were looking for her to receive. Since the amount of time that had passed since your initial appeal, you no longer required a hearing on the matter.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
