NOTICE OF DISMISSAL – FAILURE TO APPEAR

On March 26, 2016, NY State of Health (NYSOH) issued a notice of enrollment, stating that your Medicaid Managed Care plan coverage with Empire Blue Cross Blue Shield would begin effective May 1, 2016. You appealed this notification insofar as you were seeking for such coverage to begin no later than April 1, 2016.

On September 22, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for October 17, 2016, at 11:00 a.m.

On October 17, 2016, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH, [REDACTED], at 11:00 a.m. and 11:11 a.m. On the second call attempt, the Hearing Officer received an automated response stating “the phone number you have dialed is temporarily out of service.” Accordingly, we could not reach you. Please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
