NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On April 19, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you and your spouse were eligible for advance premium tax credits and no longer eligible for Medicaid. This eligibility was effective May 1, 2016. You appealed that determination.

On October 26, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because of the lapse in time from filing the appeal and because your spouse can now obtain health insurance through his employer.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
