NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

Dear [REDACTED],

On April 19, 2016, NY State of Health (NYSOH) issued an enrollment confirmation notice, stating that you, [REDACTED], were enrolled in a Medicaid Managed Care Plan, effective June 1, 2016. You appealed that determination.

On November 1, 2016, a Hearing Officer from the Appeals Unit of NY State of Health called you and you authorized your aunt to appear on your behalf. The Hearing Officer placed you and your aunt under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because, although dissatisfied with having to go without services for several months, you had no medical bills for the months you were without a Medicaid Managed Care plan such that the issue is moot.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
