NOTICE OF DISMISSAL

On April 28, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you are not qualified to enroll through NYSOH. You appealed this determination.

On October 27, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 14, 2016 at 3:00 pm.

A Hearing Officer called you at 3:00 pm with the assistance of Spanish Interpreter [REDACTED] and at 3:16 pm with the assistance of Spanish Interpreter [REDACTED] on November 14, 2016. Although you answered the call, you indicated you did not require a hearing and did not want to proceed, however, you declined to formally withdraw the request for a hearing.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
