NOTICE OF DISMISSAL – FAILURE TO APPEAR

On April 30, 2016, New York State of Health (NYSOH) issued an eligibility determination notice stating that you were eligible and your spouse was conditionally eligible for up to \$434.00 of advance premium tax credit and cost-sharing reductions, effective as of June 1, 2016. You requested an appeal insofar as the amount of financial assistance you were determined eligible to receive.

On October 25, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for November 10, 2016 at 10:00 am.

On November 10, 2016, a Hearing Officer from the NYSOH Appeals Unit attempted to contact you using the telephone number that you provided to NYSOH between 10:00 am and 10:30 am. However, there was no answer. Accordingly, we were unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
