Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did the NY State of Health (NYSOH) properly determine that your children's enrollment in their Child Health Plus plan was effective July 1, 2016?

Procedural History

On May 17, 2016, NYSOH issued a notice of eligibility determination, based on your May 16, 2016 application, stating that your children were eligible to enroll in a full price Child Health Plus plan or a Child-Only qualified health plan, effective July 1, 2016.

Also on May 17, 2016, NYSOH issued a notice of enrollment, based on your plan selection on May 16, 2016, stating that your children were enrolled in a Child Health Plus plan, and that this enrollment in the plan would start July 1, 2016.

On May 17, 2016 you spoke to NYSOH's Account Review Unit and appealed the start date of your children's Child Health Plus plan insofar as it did not begin June 1, 2016.

On November 23, 2016 you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on May 16, 2016.
- 2) You testified, and the record reflects, that you enrolled your children into a Child Health Plus plan on May 16, 2016.
- 3) You testified that you need your children's Child Health Plus plan to begin on June 1, 2016 because their coverage through your spouse's employer sponsored health insurance ended May 31, 2016, and one of your children has medical bills for June 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

The "period of eligibility" for Child Health Plus is "that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date," unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

"A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs as family circumstances change and avoids gaps or overlaps in coverage" (42 CFR § 457.340(f)).

The State of New York has provided that a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue is whether NYSOH properly determined that your children's enrollment in their Child Health Plus plan was effective July 1, 2016.

You testified that you contacted NYSOH on May 16, 2016 and enrolled your children into a Child Health Plus plan.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Since you selected a plan for your children on May 16, 2016 it would have properly began on the second month after May, which is July 1, 2016.

Therefore, the May 17, 2016 eligibility determination and May 17, 2016 enrollment confirmation notice stating that your child's enrollment in their Child Health Plus plan was effective July 1, 2016, are correct and must be AFFIRMED.

Decision

The May 17, 2016 eligibility determination is AFFIRMED.

The May 17, 2016 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your children's eligibility.

The effective date of your children's Child Health Plus plan is July 1, 2016.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

If you wish to be represented by an attorney in bringing an outside appeal and do not know how to go about getting one, you may contact legal resources available to you. You may, for example, contact the local County Bar Association, Legal Aid, or Legal Services.
