NOTICE OF DISMISSAL – FAILURE TO APPEAR

On July 28, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating in part that you were eligible for advance premium tax credits, effective September 1, 2016. You appealed this determination.

On December 16, 2016, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for January 6, 2017, at 2:00 p.m.

On January 6, 2017, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH at 2:00 p.m., 2:01 p.m., and 2:02 p.m., but that telephone number, [REDACTED], when dialed each time made two beeping sounds followed by an automated response which stated “this is not a working number.” Therefore, the Hearing Officer was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

Please contact NYSOH immediately and update your account with a working telephone number.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
