Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective October 1, 2016?

Procedural History

On August 30, 2016, NY State of Health (NYSOH) received your application for health insurance. That day, a preliminary eligibility determination was prepared stating that you were eligible to enroll in the Essential Plan, effective October 1, 2016. You selected an Essential Plan for enrollment.

On August 30, 2016, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin on September 1, 2016.

On August 31, 2016, NYSOH issued an eligibility determination notice, based on your August 30, 2016 application, stating that you were eligible to enroll in the Essential Plan, effective October 1, 2016.

On August 31, 2016, NYSOH issued a notice of enrollment, based on your plan selection on August 30, 2016, stating that you were enrolled in an Essential Plan, and that your plan would start on October 1, 2016.

On January 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You submitted an application to NYSOH for financial assistance on August 30, 2016.
- 2) You testified, and the record reflects, that you enrolled in an Essential Plan on August 30, 2016.
- 3) You testified that you wanted your enrollment in an Essential Plan to begin on September 1, 2016 because you incurred medical costs for services rendered during September 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see *also* 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective October 1, 2016.

You testified, and the record indicates, that you updated your NYSOH application on August 30, 2016. As a result, you were found eligible for the Essential Plan as of October 1, 2016 and enrolled into a plan that day.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On August 30, 2016, you selected an Essential Plan, so your enrollment properly took effect on the first day of the second following month; that is, on October 1, 2016.

Therefore, the August 31, 2016 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective October 1, 2016, is correct and must be AFFIRMED.

Decision

The August 31, 2016 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Health Plan is October 1, 2016.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

If you wish to be represented by an attorney in bringing an outside appeal and do not know how to go about getting one, you may contact legal resources available to you. You may, for example, contact the local County Bar Association, Legal Aid, or Legal Services.
