## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid from August 1, 2016 through August 31, 2016?

## Procedural History

On August 26, 2016, NYSOH received your updated application for financial assistance.

On August 27, 2016, a notice was issued stating more information was needed to make a determination on your eligibility for financial assistance. You were asked to provide proof of your income by September 10, 2016.

On September 14, 2016, NYSOH received your income documentation.

Your income documentation was verified on September 22, 2016.

On September 23, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid because your household income of \$10,800.00 is at or below the allowable income limit. This eligibility was effective as of September 1, 2016. The notice further stated you had requested help paying medical bills for the three-month period prior to your application.

On September 23, 2016, NYSOH issued an eligibility redetermination notice stating that you were not eligible for Medicaid from August 1, 2016 through August 31, 2016 because the monthly household income of \$1,939.21 is over the allowable monthly income limit of \$1,367.00.

On September 24, 2016, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice insofar as it denied retroactive Medicaid for the month of August, 2016.

On January 17, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of proceeding.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You are seeking insurance for yourself.
- 2) You testified that you expect to file your 2016 federal income tax return as single, and claim no dependents.
- 3) You were initially found eligible for Medicaid as of September 1, 2016. You testified that you are seeking retroactive Medicaid coverage for the month of August, 2016.
- 4) You testified your income varies from month to month based on the number of hours you work.
- 5) The record supports you uploaded income documentation in the form of paystubs from your employer on September 14, 2016 showing check dates of August 5, 12, 19, and 26, 2016 in the gross amount of \$381.12, \$297.02, \$483.79, \$410.41 respectively. See documents [REDACTED].
- 6) You testified you received no other source of income for the month of August, 2016.
- 7) The record supports your income documentation was verified on September 22, 2016.
- 8) You testified you have outstanding medical bills for the month of August, 2016 in the amount of approximately \$4,000.00.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid for Adults between the Ages of 19 and 65

Medicaid through NYSOH can be provided to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR §§ 435.119(b), 435.911(b)(1), 435.603(d)(4); N.Y. Soc. Serv. Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (is 81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

## **Legal Analysis**

The issue under review is whether NY State of Health (NYSOH) properly determined that you were not eligible for Medicaid from August 1, 2016 through August 31, 2016.

You are in a one-person household; you file your taxes with a tax filing status of single and claim no dependents.

You were initially found eligible for Medicaid in the September 23, 2016 eligibility determination notice. According to this notice, your coverage with Medicaid began September 1, 2016.

You testified that you are seeking to have your Medicaid coverage retroactively applied for the month of August, 2016.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in August, 2016, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,367.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during August, 2016.

You testified that your income varies based on the hours you work. You uploaded paystubs dated August 5, 12, 19, and 26, 2016 in the gross amount of \$381.12, \$297.02, \$483.79, \$410.41 respectively.

Therefore, the record indicates that in the month of August, 2016, you had a monthly household income of \$1,572.34.

Since your income of \$1,572.34 was more than the \$1,367.00 monthly Medicaid limit for 2016, NYSOH properly determined that you were not eligible for Medicaid coverage during that month. Therefore, the September 23, 2016 eligibility determination stating that you were not eligible for Medicaid in the month of August, 2016, is correct and is AFFIRMED insofar as it found you ineligible for Medicaid, and MODIFIED in the amount of income you received for that month to \$1,572.34.

## **Decision**

The September 23, 2016 eligibility determination is AFFIRMED insofar as you were determined ineligible for Medicaid for that month.

The September 23, 2016 eligibility determination is MODIFIED to reflect your monthly income for August 2016 was \$1,572.34

## **How this Decision Affects Your Eligibility**

You are not eligible for Medicaid in the month of August, 2016.

Your eligibility for Medicaid was effective as of September 1, 2016.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to U.S. Department of Health and Human Services or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the U.S. Department of Health and Human Services. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

If you wish to be represented by an attorney in bringing an outside appeal and do not know how to go about getting one, you may contact legal resources available to you. You may, for example, contact the local County Bar Association, Legal Aid, or Legal Services.

## **Summary**

The September 23, 2016 eligibility determination is AFFIRMED insofar as you were determined ineligible for Medicaid for that month.

The September 23, 2016 eligibility determination is MODIFIED to reflect your monthly income for August 2016 was \$1,572.34

You are not eligible for Medicaid in the month of August, 2016.

Your eligibility for Medicaid was effective as of September 1, 2016.
