## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On October 27, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that your child was eligible to enroll in Child Health Plus (CHP) plan at full cost, and you were eligible to purchase a qualified health plan (QHP) at full cost. The eligibility determination was effective December 1, 2016. You appealed this determination insofar as you were seeking that coverage for both you and your child begin no later than her date of birth, [REDACTED].

On March 23, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because both you and your child were subsequently found eligible for Medicaid, effectively beginning October 1, 2016.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us in writing within 30 days after the date on this notice.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
