NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 11, 2016, NY State of Health (NYSOH) issued an enrollment notice, stating that your child's coverage under his Child Health Plus (CHP) plan would begin effective December 1, 2016. You appealed insofar as you were seeking for your child's CHP plan coverage to begin no later than November 1, 2016.

On January 25, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 25, 2017, at 3:00 p.m.

On February 25, 2017, a Hearing Officer attempted to call you at the telephone number that you provided to NYSOH at 3:00 p.m., but the phone number you provided, was not in service. Please contact NYSOH immediately and update your account.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days of the Decision Date on this notice. In that writing, you must provide a working phone number that the Hearing Officer can use to contact you for a hearing, or provide assurances that your current phone number will be working in time for the hearing.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.

If your request to vacate this dismissal is granted and your phone still is not working by the time of the rescheduled hearing, no further hearings will be scheduled with regard to this appeal.
