NOTICE OF DISMISSAL

On November 12, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for the Essential Plan for a limited time, effective December 1, 2016. The notice stated you needed to provide additional information to confirm your income before January 30, 2017. You appealed this determination.

On January 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for February 14, 2017, at 10:00 a.m.

On February 14, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 10:00 a.m., 10:15 a.m., and 10:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled your case was dismissed.

You contacted NYSOH on February 16, 2016 and requested a new hearing date as you stated you never received the notice of hearing.

Your request to vacate your dismissal was granted by the NYSOH Appeals Unit on March 1, 2017.

On March 6, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 3, 2017, at 11:00 a.m.

A Hearing Officer called you at 11:00 a.m. on April 3, 2017. Although you answered the call, you testified you could not go forward with an appeal hearing because you were on your way to work. You testified you did not need a telephone hearing because your hospital bills were now covered and your insurance was backdated to November 1, 2016. The Hearing Officer explained there was nothing in the record showing your health insurance was backdated to November 1, 2016, and that your hearing was scheduled for 11:00 a.m. You testified you still would not be able to go forward with a telephone hearing because you were on your way into work. The hearing officer then confirmed your address on the notice of telephone hearing and explained your hearing was scheduled for that day at 11:00 a.m. and would be sending a dismissal notice which you could respond to if you believe your hearing should not be dismissed. You testified you understood.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
