Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for Medicaid for September 1, 2015 through September 30, 2015?

Procedural History

On December 17, 2015, you submitted an application for financial assistance with health insurance and requested help for paying medical bills for September, October, and November 2015.

On December 18, 2015, NYSOH issued a notice of eligibility determination stating that you were eligible for enrollment in the Essential Plan. This eligibility was effective as of January 1, 2016.

On September 18, 2016, NYSOH issued an eligibility determination notice stating that you were not eligible for Medicaid for September 1, 2015 through November 30, 2015 because the program you were eligible for could not pay for any care you received in the past.

On November 17, 2016, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination notice, insofar as it denied retroactive Medicaid for the months of September, October, and November 2015.

On March 3, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing held open through March 20, 2017 to allow you to submit supporting documents.

As of March 21, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are seeking Medicaid for the month of September 2015, as that is the month in which you incurred medical expenses.
- 2) You testified that there was one person in your household as of September 2015.
- 3) You filed your 2015 tax return with a tax filing status of single (Document [REDACTED]).
- 4) You submitted an application for financial assistance on December 17, 2015, and requested assistance with medical bills from the past three months.
- 5) Your application submitted on December 17, 2015, states that for the month of September 2015, your income was \$1,561.33. You testified that you do not know whether that amount is correct.
- 6) You testified that you work as an independent contractor, but for only one company.
- 7) The record does not contain any documentation or your income for the month of September 2015, and you did not fax or upload any income documentation after the hearing.
- 8) You testified that you went to the hospital in September 2015, at which time you were unaware that your previous health insurance coverage was not active. Because of that, you incurred hospital bills in the month of September 2015.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Adults between the Ages of 19 and 65

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2015 FPL, which is \$11,770.00 for a one-person household (80 Federal Register 3236, 3237).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Legal Analysis

The issue under review is whether NYSOH properly determined that you were not eligible for Medicaid in the month of September 2015.

You were in a one-person household in September 2015; you filed your 2015 tax return with a tax filing status of single, and claimed no dependents.

You submitted an application for financial assistance on December 17, 2015 and requested help in paying for medical bills for September 1, 2015 through November 30, 2015. At the hearing, you clarified that you are appealing only your eligibility for Medicaid in the month of September 2015.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether that initial application resulted in Medicaid going forward. Instead,

an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual's initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in September 2015, you would have needed to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,353.00 per month. There is no indication in the record that you would have been ineligible for Medicaid based on non-financial criteria during September 2015.

You testified that you are an independent contractor who works for one company. Your application of December 17, 2015 listed a monthly income of \$1,561.33. You testified that you did not know whether this amount was correct, so the record was left open until March 20, 2017 so that you could provide documentation of your income in the month of September 2015. No further documentation was submitted after the hearing.

Therefore, the only income information NYSOH has regarding your income for the month of September 2015 is the amount stated in the December 17, 2015 application. Since that amount of \$1,561.33 was more than the \$1,353.00 monthly Medicaid limit for September 2015, you were not financially eligible for Medicaid in the month of September 2015, based on the information available in the record. Therefore, the September 18, 2016 eligibility determination, insofar as it stated that you were not eligible for Medicaid in the month of September 2015, is AFFIRMED.

Decision

The September 18, 2016 eligibility determination is AFFIRMED.

If You Disagree with this Decision (Appeal Rights)

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
