## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health provide a timely determination of your Medicaid eligibility as of November 26, 2016?

Did NY State of Health properly determine that your Medicaid Managed Care plan began January 1, 2017?

## Procedural History

On October 25, 2016, NY State of Health (NYSOH) received your application for financial assistance with your health insurance.

On October 26, 2016, NYSOH issued a notice stating more information was needed to make a determination. The notice explained the income information you provided NYSOH did not match what was obtained from state and federal data sources. You were asked to submit income documentation for your household by November 9, 2016.

On November 9, and 11, 2016, NYSOH received your application for health insurance. Also on these dates you uploaded copies of your income documentation to your account.

On November 9, 10, and 12, 2016, NYSOH issued a notice stating more information was needed to make a determination. The notice explained the income information you provided NYSOH did not match what was obtained from

state and federal data sources. You were asked to submit income documentation for your household by November 24, 2016.

On November 25, 2016, NYSOH verified the paystubs you uploaded as documentation and a new application was submitted on your behalf.

On November 26, 2016, NYSOH issued an eligibility determination notice was issued stating you were eligible for Medicaid effective November 1, 2016.

On November 27, 2016, you selected a Medicaid Managed Care plan.

On November 29, 2016, an enrollment confirmation notice was issued confirming your selection of a Medicaid Managed Care plan on November 27, 2016. The notice confirmed your enrollment in a plan starting January 1, 2017.

On December 2, 2016, you contacted the NYSOH Account Review Unit and requested an appeal of the start date of your Medicaid Managed Care plan, requesting that it begin December 1, 2016.

On March 13, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you are appealing your enrollment start date of your Medicaid Managed Care plan.
- 2) According to your NYSOH account, NYSOH received your application for financial assistance on October 25, 2016.
- 3) The record supports a NYSOH representative assisted you with your application on October 25, 2016. You testified this was correct.
- 4) Your application submitted on October 25, 2016 stated you had a household income of \$1,000.00. You testified this was not correct.
- 5) On November 9, 2016, you submitted an updated application with an increased annual household income amount of \$15,677.00.
- 6) On November 9, 2016, you submitted income documentation showing you received \$15,677.00 from [REDACTED] with a check date of December 30, 2015. You testified this was your only

income for 2015, and expected the same amount for 2016. See Document [REDACTED]

- 7) On November 25, 2016, your income documentation was verified as acceptable proof of income.
- 8) The record reflects that you selected a Medicaid Managed Care plan on November 27, 2016.
- 9) You testified that you want your Medicaid Managed Care plan to begin on December 1, 2016 because you incurred medical costs for prescriptions.
- 10) You testified you are not sure if your medical costs would be covered by Medicaid Fee-for-Service, and that you did not have your card at the time you received medical services in December, 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13ADM-03(III)(F)).

### Verification Process

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income (45 CFR § 155.320(c)(1)(i), 42 CFR § 435.945).

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the

opportunity to submit satisfactory documentary evidence (45 CFR §155.315(f) 42 CFR § 435.952).

### Timely Notice of Medicaid Eligibility

When an individual applies for insurance through NYSOH, NYSOH must determine that person's eligibility promptly and without undue delay (45 CFR § 155.310(e)(1); 42 CFR § 435.1200(b)(3)(iii)).

To assess whether an eligibility determination was untimely, NYSOH must base the time period from the date of application to the date NYSOH notifies the applicant of its decision (45 CFR § 155.310(e)(2)). However, if the applicant submits an incomplete application or there is not sufficient information for NYSOH to make an eligibility determination, then NYSOH must notify that applicant that more information is needed to complete the application (45 CFR § 155.310(k)(1)).

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the application (42 CFR § 435.912).

## **Legal Analysis**

The first issue is whether NYSOH's provided you with timely determination of your Medicaid eligibility as of November 26, 2016.

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income.

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence.

You updated your NYSOH account on October 25, 2016. The income amount that was entered into this application did not match federal and state data sources. As a result, NYSOH asked that you submit additional documentation to confirm your income by November 9, 2016.

On November 9, and 11, 2016, NYSOH you uploaded copies of your income documentation to your account. NYSOH verified the documentation as acceptable proofs of income on November 25, 2016 and submitted a new application on your behalf.

Therefore, your application was considered complete as of November 11, 2016 for purposes of issuing an eligibility determination.

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the completed application. To assess whether an eligibility determination was untimely, NYSOH must base the time period from the date of the completed application to the date NYSOH notifies the applicant of its decision.

NYSOH issued an eligibility determination notice on November 26, 2016, stating you were eligible for Medicaid effective November 1, 2016. Since NYSOH issued an eligibility determination 15 days from the date your application was considered complete, the November 26, 2016 eligibility determination notice was timely and is AFFIRMED.

The second issue is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan was effective January 1, 2017.

The record reflects that you contacted NYSOH on November 27, 2016 and enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

Since the November 26, 2016 eligibility determination notice was timely issued, you were able to select a Medicaid Managed Care plan as of November 26, 2016. Your plan would therefore properly take effect on the first day of the second month following November; that is, on January 1, 2017.

Therefore, the November 29, 2016 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective January 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The November 26, 2016 eligibility determination notice was timely and is AFFIRMED.

The November 29, 2016 enrollment confirmation notice is AFFIRMED.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
