Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly disenroll you from your Medicaid Managed Care plan effective November 30, 2016?

Did NYSOH properly determine that your enrollment in your Essential Plan was effective January 1, 2017?

Procedural History

On January 12, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid effective February 1, 2016.

You were subsequently enrolled in a Medicaid Managed Care plan effective January 1, 2016.

On October 9, 2016, NYSOH issued a notice that it was time to renew your health insurance. That notice stated that, based on information from federal and state sources, NYSOH could not make a decision about whether you would qualify for financial help paying for your health coverage, and that you needed to update your account by November 15, 2016 or you might lose the financial assistance you were currently receiving.

No updates were made to your account by November 15, 2016.

On November 17, 2016, NYSOH issued an eligibility determination notice stating that you are not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. You also could not enroll in a qualified health plan at full cost. This was because you had not responded to the renewal notice and had not completed your renewal within the required time frame. Your eligibility ended December 1, 2016.

On November 23, 2016, NYSOH received your updated application for health insurance.

On November 23, 2016, disenrollment notice was issued terminating your enrollment in your Medicaid Managed Care plan effective November 30, 2016.

On November 24, 2016, NYSOH issued a notice stating the income information in your November 23, 2016 application does not match what NYSOH received from state and federal data sources. More information was required to make a determination. You were asked to provide income documentation by December 8, 2016.

On December 3, 2016, NYSOH issued a notice stating the income information in your December 2, 2016 application does not match what NYSOH received from state and federal data sources. More information was required to make a determination. You were asked to provide income documentation by December 8, 2016.

On December 8, 2016, an eligibility determination notice was issued based on your application on December 7, 2016 stating you were eligible to enroll in the Essential Plan effective January 1, 2017.

Also on December 8, 2016, you spoke to NYSOH's Account Review Unit and appealed the enrollment insofar as it began your Essential plan on January 1, 2017 and not December 1, 2016.

On December 9, 2016, an enrollment confirmation notice was issued confirming your enrollment in an Essential Plan starting January 1, 2017.

On March 22, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you receive all of your notices from NYSOH by regular mail.
- 2) You testified that you did receive the October 9, 2016 renewal notice, but that you did not receive any notice stating your Medicaid Managed Care plan would end effective December 1, 2016.
- 3) You testified that you did not know that you had been disenrolled from your Medicaid Managed Care plan until you had tried to make appointments for December, 2016.
- 4) The record reflects that on November 23, and December 2, 2016 NYSOH received your updated applications for health insurance.
- 5) NYSOH received your completed application on December 7, 2016.
- 6) You testified, and the record reflects, that you selected your Essential Plan on December 8, 2016, and that your enrollment was effective on January 1, 2017.
- 7) No notices sent to you at the address listed on your NYSOH account have been returned as undeliverable.
- 8) You testified that you want your Medicaid Managed Care plan to continue through to December 31, 2016.
- 9) You testified you are seeking reimbursement for [REDACTED] appointments totaling \$145.00 for October, November, and December, 2016 which were not covered. You testified your physician does not accept Medicaid.
- 10) You testified you are seeking reimbursement for a \$400.00 [REDACTED] appointment for the month of December 2016. You testified your [REDACTED] does not accept Medicaid or the Essential Plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid Renewal

In general, NYSOH must review Medicaid eligibility once every twelve months or “whenever it receives information about a change in a beneficiary’s circumstances that may affect eligibility” (42 CFR § 435.916(a)(1), (d)). NYSOH must make its “redetermination of eligibility without requiring information from the individual if able to do so based on reliable information contained in the individual’s account or other more current information available to the agency, including but not limited to information accessed through any data bases accessed by the agency” (42 CFR § 435.916(a)(2)).

NYSOH must provide an individual with the annual redetermination notice, including the projected eligibility for coverage and financial assistance, and must require the qualified individual to report any changes within 30 days (45 CFR § 155.335(c), (e)). Once the 30-day period has lapsed, NYSOH must issue a redetermination as provided by the notice, with consideration given to any updates provided by the individual (45 CFR §155.335(h)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H(6)(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019, N.Y. Soc. Serv. Law §364-j(1)(c); 18 NYCRR § 360-10.3(h)).

Continuous Coverage

Most applicants determined eligible for Medicaid are guaranteed 12 months of Medicaid coverage offered through Medicaid Managed Care, even if the adult loses Medicaid eligibility because of any changes or updates they make to their account. For example, even if income increases above the Medicaid limit allowed for the household size, the insured will remain covered under Medicaid for a 12-month period. This 12-month period is referred to as “continuous coverage,” and is set based on the start date of the original Medicaid eligibility determination or the date of any subsequent Medicaid eligibility determination based on modified adjusted gross income (see 42 CFR § 435.916; NY Social Services Law (NY SSL) § 366(4)(c)).

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The first issue is whether NYSOH properly disenrolled you from your Medicaid Managed Care plan effective November 30, 2016.

You were originally found eligible for Medicaid effective February 1, 2016. You were enrolled into a Medicaid Managed Care plan effective January 1, 2016.

Generally, NYSOH must redetermine a qualified individual's eligibility for Medicaid once every 12 months without requiring information from the individual if able to do so based on reliable information contained in the individual's account or other more current information available to the agency. NYSOH's October 9, 2016 renewal notice stated that there was not enough information to determine whether you were eligible to continue your financial assistance for health insurance, and that you needed to supply additional information by November 15, 2016, or your financial assistance might end.

Because there was no timely response to this notice, you were terminated from your Medicaid Managed Care plan effective November 30, 2016.

However, most applicants determined eligible for Medicaid are guaranteed 12 months of Medicaid coverage, even if the adult loses Medicaid eligibility because of any changes or updates they make to their account. For example, even if income increases above the Medicaid limit allowed for the household size, the insured will remain covered under Medicaid for a 12-month period. This 12-month period is referred to as "continuous coverage," and is set based on the start date of the original Medicaid eligibility determination or the date of any subsequent Medicaid eligibility determination based on modified adjusted gross income

Since you were determined eligible for Medicaid effective February 1, 2016, your eligibility would continue for 12 months until January 31, 2016 regardless of whether your income increased above the Medicaid limit.

Therefore, NYSOH's November 17, 2016, eligibility redetermination notice stating that you are not eligible for Medicaid because you had not responded to the renewal notice and had not completed your renewal within the required time frame effective November 30, 2016 is RESCINDED.

The November 23, 2016, disenrollment notice terminating your enrollment in your Medicaid Managed Care plan effective November 30, 2016 is RESCINDED.

Your case is RETURNED to NYSOH to reinstate your Medicaid Managed Care plan for the month of December, 2016.

The second issue is whether NYSOH properly determined that your enrollment in the Essential Plan was effective January 1, 2017

You testified, and the record indicates, that you submitted your completed NYSOH application on December 7, 2016. You were found eligible for the Essential Plan as of January 1, 2016 and enrolled into a plan on December 8, 2016.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On December 8, 2016, you selected an Essential Plan, so your enrollment properly took effect on the first day of the first month following December; that is, on January 1, 2017.

Therefore, the December 9, 2016 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective January 1, 2017, is correct and must be AFFIRMED.

Decision

The November 17, 2016, eligibility redetermination notice is RESCINDED.

Your Medicaid Managed Care plan ended December 31, 2016.

The effective date of your Essential Plan is January 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
