Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health properly determine that your enrollment in an Essential Plan was effective January 1, 2017?

Procedural History

On November 19, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, based on your November 18, 2016 application, stating that you were eligible to enroll in the Essential Plan, effective January 1, 2017.

On December 13, 2016 you enrolled in an Essential Plan.

Also on December 13, 2016, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in the Essential Plan insofar as it did not begin on December 1, 2016.

On December 14, 2016, NYSOH issued a notice of enrollment confirmation stating that you were enrolled in an Essential Plan, and that your plan would start January 1, 2017.

On March 17, 2017 you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you updated your NYSOH application for financial assistance on November 18, 2016.
- 2) NYSOH records reflect that you became eligible for the Essential Plan on November 18, 2016.
- 3) On November 19, 2016, NYSOH issued an eligibility determination stating that you were eligible for the Essential Plan, effective January 1, 2017.
- 4) You testified that you did not remember when you selected an Essential Plan.
- 5) You testified that you contacted NYSOH in December 2016 because you had not received an insurance card or information from your Essential Plan.
- 6) NYSOH records reflect that you enrolled in an Essential Plan on December 13, 2016.
- 7) You testified that you are requesting that your enrollment in an Essential Plan to begin on December 1, 2016.
- 8) You testified that you incurred prescription medication costs during December 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan Effective Date

For individuals seeking enrollment in an Essential Plan, New York State has elected to follow the same rules that NYSOH uses in determining effective dates for individuals seeking enrollment in qualified health plans (NY Social Services Law § 369-gg(4)(c); New York's Basic Health Plan Blueprint, p. 16, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

The effective date of coverage by an Essential Plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible

for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i); see also 42 CFR § 600.320). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in an Essential Plan was effective January 1, 2017.

You testified, and the record indicates, that you updated your NYSOH application on November 18, 2016. As a result, you were found eligible for the Essential Plan on the same date.

You testified that you did not remember when you selected an Essential Plan. You testified that you contacted NYSOH in December 2016 because you had not received an insurance card or information from your Essential Plan. NYSOH records reflect that you enrolled in an Essential Plan on December 13, 2016.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

On December 13, 2016, you selected an Essential Plan, so your enrollment properly took effect on the first day of the following month; that is, on January 1, 2017. Even if you had selected a plan on November 18, 2016, it still would not have been effective until January 1, 2017.

Therefore, the December 14, 2016 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective January 1, 2017, is correct and must be AFFIRMED.

Decision

The December 14, 2016 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your eligibility.

The effective date of your Essential Health Plan is January 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
