Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your newborn child was not eligible for Medicaid in November 2016?

Did the NYSOH properly determine that your newborn child's enrollment in her Child Health Plus plan was effective December 1, 2016?

Procedural History

On December 12, 2016, your newborn child was added to your NYSOH account.

On December 13, 2016, NYSOH issued a notice of eligibility determination, based on your December 12, 2016 application, stating that your newborn child was eligible to enroll in Child Health Plus with a \$60.00 monthly premium, effective January 1, 2017.

Also on December 13, 2016, NYSOH issued a notice of eligibility determination, based on your December 12, 2016 application, stating that your newborn child was not eligible for retroactive Medicaid coverage in November 2016 because the monthly household income of \$5,442.67 was over the allowable income limit.

On December 14, 2016, you spoke to NYSOH's Account Review Unit and appealed the start date of your newborn child's Child Health Plus plan and denial of retroactive Medicaid coverage insofar as she did not have coverage in November or December 2016.

On December 15, 2016, NYSOH issued a notice of enrollment, based on your plan selection on December 14, 2016, stating that your newborn child was enrolled in a Child Health Plus plan, and that this enrollment in the plan would start January 1, 2017.

On December 16, 2016, NYSOH issued a notice of enrollment, stating that your newborn child was enrolled in a Child Health Plus plan, and that this enrollment in the plan would start December 1, 2016.

On May 2, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are appealing only your newborn child's eligibility and enrollment start date, seeking coverage for November 2016.
- 2) You submitted an application to NYSOH for financial assistance on December 12, 2016.
- 3) You file your taxes with a tax filing status of married filing jointly and will claim two dependents on your tax return
- 4) The record reflects that you enrolled your newborn child into a Child Health Plus plan on December 14, 2016.
- 5) According to Complaint # [REDACTED], on December 14, 2016 you requested that your newborn child's coverage be backdated. The request was approved, and her enrollment start date was modified to December 1, 2016.
- 6) You testified that you need your newborn child's Child Health Plus plan to begin on her date of birth, [REDACTED], because she has outstanding medical bills from services rendered in November 2016.
- 7) You testified that your household's income in December 2016 was \$5,442.67.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid for Children

A child who is under one year of age is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 223% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.118(c); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

In the case of an individual who expects to file a tax return and does not expect to be claimed by another taxpayer, the household consists of the taxpayer and all persons whom such individual expects to claim as a tax dependent (42 CFR § 435.603(f)(1)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$24,300.00 for a four-person household (81 Fed. Reg. 4036).

Retroactive Medicaid

The Department of Health must make Medicaid coverage start retroactively for up to three months prior to the month of an initial application if the individual received medical services that would have been covered under Medicaid and the individual would have been eligible for Medicaid at the time he received the services if he had applied (42 USCA § 1396A(34); 42 CFR § 435.915(a)). The Department of Health may make eligibility effective for fee-for-service Medicaid on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Child Health Plus

The “period of eligibility” for Child Health Plus is “that period commencing on the first day of the month during which a child is an eligible child and enrolled or recertified for enrollment on an annual basis based on all required information and documentation and ending on the last day of the twelfth month following such date,” unless the CHP premiums are not timely paid or the child no longer resides in New York State, gains access to or obtains other health insurance coverage, or becomes eligible for Medicaid (NY Public Health Law § 2510(6)).

“A State must specify a method for determining the effective date of eligibility for [Child Health Plus], which can be determined based on the date of application or through any other reasonable method that ensures coordinated transition of children between [Child Health Plus] and other insurance affordability programs

as family circumstances change and avoids gaps or overlaps in coverage” (42 CFR § 457.340(f)).

The State of New York has provided that a child’s period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see e.g. State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your newborn child was not eligible for Medicaid in November 2016.

Your newborn child is in a four-person household. The record reflects that you file your taxes with a tax filing status of married filing jointly and will claim two dependents on your tax return.

You submitted an application for financial assistance on December 12, 2016 and requested help in paying for medical bills for your newborn child in November 2016.

When an individual files an initial application for Medicaid, his or her eligibility for retroactive Medicaid depends on the date of application. To this end, it does not matter whether or not that initial application resulted in Medicaid going forward. Instead, an individual, who has filed an initial application for Medicaid through NYSOH, has the right to be evaluated for Medicaid for the three months before the month of his or her application.

Medicaid coverage can be made effective retroactively for up to three months prior to an individual’s initial application if the individual received medical services that would have been covered under Medicaid and if they would have been eligible for Medicaid in those three months had they applied.

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size. To be eligible for Medicaid in November 2016, your newborn would have needed to meet the non-financial criteria and have an income no greater than 223% of the FPL, which is \$4,516.00 per month. There is no indication in the record that your newborn child would have been ineligible for Medicaid based on non-financial criteria during November 2016.

You credibly testified that your household's monthly income for November 2016 was \$5,442.67.

Since your income of \$5,442.67 was more than the \$4,516.00 monthly Medicaid limit for November 2016, NYSOH properly determined that your newborn child was not eligible for Medicaid coverage during that month. Therefore, the December 13, 2016 eligibility determination stating that your newborn child was not eligible for Medicaid in the month of November 2016, is correct and is AFFIRMED.

The second issue is whether NYSOH properly determined that your newborn child's enrollment in her Child Health Plus plan was effective December 1, 2016.

You testified that you submitted an application for financial assistance to NYSOH on December 12, 2016. The record reflects that you enrolled your newborn child into a Child Health Plus plan on December 14, 2017.

The date on which a Child Health Plus plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected between the first day and fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month and the end of the month goes into effect on the first day of the second following month.

Therefore, the December 15, 2016 enrollment confirmation notice stating that your newborn child's enrollment in her Child Health Plus plan was effective January 1, 2017 is correct. However, NYSOH subsequently approved a backdate request per Complaint # [REDACTED], and your newborn child's coverage was modified to begin on December 1, 2016. This was confirmed in an enrollment confirmation notice dated December 16, 2016.

Since NYSOH approved your backdate request, the December 16, 2016 enrollment confirmation notice stating that your child's enrollment in her Child Health Plus plan was effective December 1, 2016, is correct and must be AFFIRMED.

Decision

The December 13, 2016 eligibility determination notice is AFFIRMED.

The December 16, 2016 enrollment confirmation notice is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not change your newborn child's eligibility.

Your newborn child was properly determined not eligible for Medicaid in the month of November 2016.

The effective date of your child's Child Health Plus plan is December 1, 2016.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
