Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children were not eligible to enroll in Child Health Plus (CHP), as of your November 22, 2016 application?

Procedural History

On November 22, 2016, NYSOH received your application for health insurance.

On November 23, 2016, NYSOH issued an eligibility determination notice stating that you and your children were eligible to purchase a qualified health plan at full cost, effective January 1, 2017. The notice further stated that your children were not eligible for CHP because they were currently enrolled in, or had access to, coverage through the NY State Health Insurance Program (NYSHIP).

On December 16, 2016, you spoke to NYSOH's Account Review Unit and appealed that determination, insofar as your children were not eligible for coverage through CHP.

On March 24, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified you work for New York State, and your NYSOH account reflects that you work for the [REDACTED].
- 2) You testified that you have health insurance coverage available to you through your [REDACTED].
- 3) You testified that you are appealing on behalf of your children only, as you believe that individual coverage for yourself only is affordable through NYSHIP, but that family coverage is not.
- 4) You testified that the cost of a family plan through NYSHIP is \$208.92 per pay period, and that your annual salary is \$39,645.00.
- 5) You testified that you are a single mother taking care of all household expenses, including food, clothing, housing, and child care, as well as all other expenses, so the coverage offered through NYSHIP is not affordable.
- 6) You testified that you and your children are currently enrolled in coverage through the Empire Plan through NY State.
- 7) You testified that you would like your children to be eligible for CHP.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

Child Health Plus (CHP) is a sliding-scale-premium program for children who are in a household that is over income for regular Medicaid (see New York Public Health Law (NY PHL) § 2510 et seq. and 42 USC § 1397aa). Eligibility rules are set out in NY PHL § 2511(2), as well as in the NYS Department of Health 2008-2012 Contract and Plan Manual.

A child who meets the eligibility requirements for CHP may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (NY PHL § 2511(2)(a)(iii)). To be eligible to enroll in CHP with subsidy payments, a child must not be “eligible

for medical assistance”; that is, must not be eligible for Medicaid (NY PHL § 2511(2)(b)).

Children who have access to a state health benefits plan such as NYSHIP are not eligible to enroll in CHP (State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children were not eligible to enroll in CHP coverage.

A child is eligible to enroll in CHP if they meet the non-financial requirements, are not eligible for Medicaid, and have a household income below 400% of the FPL.

One of the non-financial eligibility requirements is that the child must not have access to a state health benefits plan such as NYSHIP. Children who have access to NYSHIP coverage are not eligible to enroll in CHP.

You testified that you work for NY State and that you have access to NYSHIP, but that the cost of family coverage, \$208.92 per pay period, is not affordable. However, affordability is not a relevant factor in this analysis, as your children’s access to NYSHIP coverage prevents them from being found eligible for CHP, pursuant to NY State policy.

Since the November 23, 2016 eligibility determination properly stated that, based on the information you provided, your children were not eligible to enroll in CHP coverage, it is correct and is AFFIRMED.

Decision

The November 23, 2016 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your children are not eligible for CHP because they have access to NYSHIP coverage.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
