## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On March 10, 2014, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to enroll in a qualified health plan with \$0.00 of monthly advance premium tax credit (APTC). The notice further stated that your health insurance coverage would begin after you had selected a health plan. Since that eligibility determination was issued, system defects have prevented you from selecting a health plan.

On December 19, 2016, you spoke with NYSOH Account Review Unit and they confirmed that the system defects still existed and that NYSOH was unable to complete an eligibility determination. You filed an appeal on that date because you were still unable to enroll in a qualified health plan.

On April 5, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you to conduct a formal telephone hearing and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because on February 16, 2017, NYS Department of Health representatives had backdated your Medicaid Fee-for-Service for the period of January 1, 2016 to October 31, 2016. Further, you testified that you had recently received an ID card showing that you had Medicaid Fee-for-Service starting February 1, 2017.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
