Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective October 31, 2016?

Did NYSOH properly determine that your eligibility for and enrollment in the Essential Plan was effective December 1, 2016?

Procedural History

On January 23, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective March 1, 2016. The notice further directed you to provide documentation confirming your income before April 21, 2016.

On January 23, 2016, NYSOH issued a notice confirming your enrollment in an Essential Plan, effective March 1, 2016.

No income documentation was received by NYSOH before April 21, 2016.

On September 18, 2016, NYSOH issued an eligibility determination notice stating that you were newly eligible to purchase a qualified health plan at full cost. The notice stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application. This eligibility was effective November 1, 2016.

On September 18, 2016 NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of October 31, 2016, because you were no longer eligible to remain in your plan.

On October 11, 2016, you updated your application for financial assistance. On October 12, 2016, a notice was issued stating the income information in your application does not match what NYSOH received from state and federal data sources. The notice asked that you provide additional proof of income by October 26, 2016.

No income documentation was received by NYSOH before October 26, 2016.

On October 28, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, effective December 1, 2016.

Also on October 28, 2016, NYSOH issue a notice of enrollment confirmation, based on your plan selection on October 27, 2016, stating that you were enrolled in an Essential Plan effective December 1, 2016.

On December 22, 2016, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the month of November, 2016.

On March 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open to April 12, 2017, to allow you to submit supporting documentation showing your faxed income documents or return fax to NYSOH.

As of April 12, 2017, the Appeals Unit did not receive any documents from you and none were viewable in your NYSOH account. Therefore, the record was closed that same day and this decision is based on the record as developed at the time of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you receive all of your notices from NYSOH by electronic mail.
- 2) You testified that you knew you needed to provide income documentation, and you faxed in documents to NYSOH before the April 21, 2016 deadline.

- 3) Your NYSOH account does not show any documentation being uploaded to your account.
- 4) Your NYSOH account does not contain any information that income documentation was reviewed by NYSOH representatives for purposes of determining your eligibility.
- 5) Your NYSOH account indicates that on September 17, 2016, your application was run and you were found no longer eligible for the Essential Plan as of October 31, 2016.
- 6) You testified that you are seeking reinstatement of your Essential Plan for the month of November 2016.
- 7) You updated your application on October 11, 2016,
- 8) You enrolled in an Essential Plan on October 27, 2016 for a December 1, 2016 start date.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR § 155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); *see also* 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); *see also* 42 CFR § 600.320(c)).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant's account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual's NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective October 31, 2016.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources in order to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination issued on January 23, 2016, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before April 21, 2016.

You testified you were aware of the January 23, 2016 determination and request for income documentation. You testified you faxed income documentation in response to this request.

Therefore, NYSOH properly notified you of an inconsistency in your account and that documentation was needed to confirm the income you listed in the account.

There is no indication in the record that NYSOH received your faxed income documentation before the April 21, 2016 deadline. There is also no evidence showing that NYSOH representatives reviewed income documentation for the purposes of determining validity of the income amount you included in your application.

The Hearing Officer provided you 15 days after your telephone hearing to provide proof of your faxed income documentation to the NYSOH Appeals Unit. At the close of the record, no documentation was received by the NYSOH Appeals Unit.

If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine an individual's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation.

Accordingly, your eligibility for the Essential Plan terminated as of October 31, 2016 after having your eligibility redetermined on September 17, 2016 based on the information available to NYSOH from state and federal data sources.

Therefore, the September 18, 2016 redetermination notice and disenrollment notices were proper and are **AFFIRMED**.

The second issue is whether NYSOH properly determined that your eligibility for and enrollment in the Essential Plan was effective December 1, 2016.

You testified, and your account confirms, that you updated your NYSOH application on October 11, 2016.

On October 12, 2016, a notice was issued stating the income information in your application does not match what NYSOH received from state and federal data sources. The notice asked that you provide additional proof of income by October 26, 2016. No documentation was received by the requested deadline.

You then updated your application on October 27, 2016 in which you were redetermined eligible for the Essential Plan effective December 1, 2016. That day you selected an Essential Plan for enrollment.

The date on which enrollment in an Essential Plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month goes into effect on the first day of the following month. A plan that is selected from the sixteenth day of the month to the end of the month goes into effect on the first day of the second following month.

Since on October 27, 2016, you selected an Essential Plan, your enrollment would properly take effect on the first day of the second month following October; that is, on December 1, 2016.

Therefore, the October 28, 2016 eligibility determination notice, and the October 28, 2016 enrollment confirmation notice stating that your enrollment in the Essential Plan was effective December 1, 2016, is correct and must be AFFIRMED.

Decision

The September 18, 2016 redetermination notice is AFFIRMED.

The September 18, 2016 disenrollment notice is AFFIRMED.

The October 28, 2016 eligibility determination notice is AFFIRMED.

The October 28, 2016 enrollment notice is AFFIRMED.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
