NOTICE OF DISMISSAL – FAILURE TO APPEAR

On December 29, 2016, NY State of Health (NYSOH) issued a plan enrollment confirmation notice, stating that you were enrolled in an Essential Plan, effective February 1, 2017. You appealed this determination.

On February 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 15, 2017, at 10:00 a.m. Due to extreme weather conditions, this hearing was adjourned.

On April 3, 2017, NYOSH issued a Notice of Hearing to advise you that the hearing you requested was rescheduled for April 25, 2017 at 9:00 a.m. You requested that day that the hearing be adjourned to a later date. The Hearing Officer agreed to rescheduled the hearing to May 2, 2017 at 9:00 a.m. and informed you that you would not be receiving a new Notice of Hearing in the mail. You agreed to this hearing time, and stated you understood you would not be receiving a Notice of Hearing in the mail.

On May 2, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 9:00 a.m., 9:15 a.m., and 9:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
