Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your eligibility for the Essential Plan ended effective December 31, 2016?

Procedural History

On August 16, 2016, NYSOH issued an eligibility determination notice stating that you were eligible to enroll in the Essential Plan for a limited time, effective September 1, 2016. The notice directed you to provide documentation confirming your income before November 13, 2016.

Also on August 16, 2016, NYSOH issued an enrollment notice confirming your start date in an Essential Plan, effective September 1, 2016.

No updates were made to your NYSOH account by November 13, 2016.

On November 20, 2016, NYSOH issued an eligibility redetermination notice stating that, effective January 1, 2017, you were newly eligible to purchase a qualified health plan at full cost. The notice further stated that you were not eligible to enroll in the Essential Plan because NYSOH did not receive the income documentation needed to verify the income listed in your application.

On November 26, 2016, NYSOH issued a disenrollment notice stating that your enrollment in the Essential Plan would end as of December 31, 2016, because you were no longer eligible to remain in your plan.

On December 29, 2016, you updated your NYSOH application for financial assistance. That day, a preliminary eligibility redetermination was prepared finding you eligible to enroll in the Essential Plan, effective February 1, 2017, and you selected an Essential Plan for enrollment.

Also on December 29, 2016, you spoke to NYSOH's Account Review Unit and appealed the termination of your Essential Plan for the month of January 2017.

On December 30, 2016, NYSOH issued an eligibility redetermination notice stating that you were conditionally eligible to enroll in the Essential Plan, effective February 1, 2017.

Also on December 30, 2016, NYSOH issue an enrollment notice confirming, based on your plan selection on December 29, 2016, that you were enrolled in an Essential Plan, effective February 1, 2017.

On March 20, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your NYSOH account confirms, that you receive all your notices from NYSOH by electronic mail.
- You testified that you did not receive any electronic alerts notifying you of any notice in your NYSOH account stating that your initial 2016 eligibility was only conditional and that you needed to provide documentation of your income.
- 3) You testified that you did not know that you needed to submit documentation of your income until you realized you were disenrolled from your health plan in November 2016.
- 4) Your NYSOH account indicates that, on November 19, 2016, your application was run and you were found no longer eligible for the Essential Plan as of December 31, 2016.
- 5) According to your NYSOH account and your testimony, you submitted income documentation to NYSOH on December 14, 2016, December 20, 2016 and January 5, 2017.

- 6) You updated the income information in your NYSOH account on December 29, 2016.
- 7) You testified that you are seeking reinstatement of your Essential Plan for the month of January 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Verification of Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present noncitizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see https://www.medicaid.gov/basic-health-program/basic-health-program.html; 42 CFR § 600.345(a)(2)).

An applicant is required to attest to their household's projected annual income. (45 CFR § 155.320(c)(3)(ii)(B)). For all individuals whose household income is needed, NYSOH must request tax return data from the Secretary of the Treasury and data regarding Social Security benefits from the Commissioner of Social Security in order to confirm that the information the applicant is attesting to is accurate (45 CFR § 155.320(c)(1)(i); 45 CFR § 155.320(c)(3)(ii)(A)).

If income data is unavailable, or if an applicant's attestation is not reasonably compatible with the income data NYSOH obtains, NYSOH must request additional information from the applicant in order to resolve the inconsistency (45 CFR §155.320 (c)(3)(iii), (iv)).

NYSOH must provide the applicant with notice of the inconsistency in their account and 90 days to provide satisfactory documentary evidence to resolve the

inconsistency (45 CFR § 155.315 (f)(2)). If NYSOH remains unable to verify the attestation of the applicant, NYSOH must redetermine the applicant's eligibility based on the information available from the data sources unless the applicant demonstrates that they are unable to provide the required documentation (45 CFR § 155.315(f)(2), (g)).

Upon making an eligibility redetermination, NYSOH must notify the applicant and implement any updates in eligibility to the Essential Plan effective the first day of the following month for changes received by NYSOH from the first to the fifteenth of any month (45 CFR § 155.420(b)(1)(i); see also 42 CFR § 600.320(c)). For updates received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR § 155.420(b)(1)(ii); see also 42 CFR § 600.320(c)).

Electronic Notices

Applicants may choose to receive notices and information from NYSOH either by electronic alerts or by regular mail. If the applicant elects to receive electronic notices, NYSOH must send an email or other electronic communication alerting the individual that a notice has been posted to the applicant's account (42 CFR § 600.330(e); 42 CFR § 435.918(b)(4)).

Additionally, if an electronic alert regarding a notice in an individual's NYSOH account fails, NYSOH must send out the notice by regular mail within three days of the failed alert (42 CFR § 435.918(b)(5)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your eligibility for the Essential Plan ended effective December 31, 2016.

An individual requesting financial assistance to help pay for the cost of coverage provided through NYSOH is required to attest to his or her household's projected annual income. For individuals seeking enrollment in the Essential Plan, NYSOH must request income data from federal data sources to verify an individual's income attestation.

If NYSOH cannot verify an individual's attestation, it must provide the individual with notice of the inconsistency and provide a period of 90 days from the date notice is received to resolve the inconsistency.

In the eligibility determination notice issued on August 16, 2016, you were advised that you were eligible for the Essential Plan for a limited time, and that you needed to confirm your household's income before November 13, 2016.

The record reflects that NYSOH did not receive the requested income documentation before the deadline.

However, you testified that you elected to receive alerts regarding notices from NYSOH electronically. You credibly testified that you did not receive an electronic alert regarding the August 16, 2016 eligibility determination notice, which advised you that your eligibility was only conditional and that you needed to submit documentation to confirm your income. There is also no evidence in your account documenting that any email alert was sent to you regarding the need to submit documentation in a timely manner; nor is there any evidence that the notice failed and, therefore, was sent to you by regular mail.

Therefore, it is concluded that NYSOH did not give you proper notice that you needed to submit documentation of your income to confirm your eligibility for the Essential Plan.

Since you were not made aware of and did not receive proper notice that there was an inconsistency in your NYSOH account, the November 20, 2016 eligibility redetermination and November 26, 2016 disenrollment notices, stating that you are no longer eligible for the Essential Plan because you failed to submit documentation and disenrolled, effective December 31, 2016, are RESCINDED.

Your case is RETURNED to NYSOH to reinstate your coverage in your Essential Plan as of January 1, 2017, and to notify you accordingly.

Decision

The November 20, 2016 eligibility redetermination notice is RESCINDED.

The November 26, 2016 disenrollment notice is RESCINDED.

Your case is RETURNED to NYSOH to reinstate your coverage in your Essential Plan as of January 1, 2017, and to notify you accordingly.

How this Decision Affects Your Eligibility

NYSOH erred in terminating your Essential Plan effective December 31, 2016, without giving proper notice.

If applicable, you will be responsible to pay the monthly premium directly to the health plan for coverage to resume for the month of January 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
