NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 20, 2014, NY State of Health (NYSOH) received your application for financial assistance with your health insurance. In this application, you requested retroactive Medicaid coverage for September 2014 and October 2014. You appealed on January 3, 2017 because you have not heard back from NYOSH about this request.

On February 15, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for March 14, 2017, at 2:00 p.m.

On March 17, 2017, NYOSH issued a Notice of Hearing Cancellation stating that your hearing that was scheduled for March 14, 2017 had been postponed due to extreme weather conditions.

On April 5, 2017, NYOSH issued a Notice of Hearing to advise you that the hearing you requested was rescheduled for May 3, 2017 at 11:00 a.m.

On May 3, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 11:00 a.m., 11:15 a.m., and 11:30 a.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
