## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible for Medicaid, effective January 1, 2017?

Did NY State of Health properly determine that you were ineligible for the Essential Plan?

## Procedural History

On January 3, 2017, NY State of Health (NYSOH) received your updated application for financial assistance with health insurance.

On January 4, 2017, NYSOH issued a notice of eligibility determination stating that you remained eligible for Medicaid, effective January 1, 2017.

On January 4, 2017, NYSOH issued a plan enrollment confirmation notice confirming your enrollment in a Medicaid Managed Care plan, effective February 1, 2017.

Also on January 4, 2017, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as you were not found eligible for the Essential Plan.

On March 14, 2017, you were scheduled for a telephone hearing with a Hearing Officer from the NYSOH's Appeals Unit. However, that hearing was postponed due to extreme weather conditions.

On May 3, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and the record was closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You are seeking insurance for yourself.
- 2) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 3) The application that was submitted on January 3, 2017 listed an annual household income of \$16,277.00, consisting of income you earn from self-employment.
- 4) You testified that you own your own company and your income varies on how well your business is and how much you decide to pay yourself for that year.
- 5) You testified that the amount you provided in your January 3, 2017 application was correct at the time based on information you were using from a prior year's income tax return.
- 6) You testified that had you known you needed to take more money from your business to qualify for the Essential Plan you would have.
- 7) Your application states that you will be taking a self-employed health insurance deduction on your 2017 tax return in the amount of \$298.00. However, you testified that you plan on taking no deductions on your 2017 tax return.
- 8) You testified, and your application states, that you live in Kings County.
- 9) You testified, and your application states, that you are a lawful permanent resident of the United States.
- 10) You testified that you want to be found eligible for the Essential Plan.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one -person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one -person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

## **Legal Analysis**

The first issue is whether NYSOH properly determined that you were eligible for Medicaid, effective January 1, 2017.

The application that was submitted on January 3, 2017 listed an annual income of \$16,277.00 and stated that you plan on taking a self-employed health insurance deduction in the amount of \$298.00 on your 2017 tax return.

During the hearing, you testified that the amount you provided in your January 3, 2017 application was correct based on a prior year's income tax return. You testified that since you own your own business that your income fluctuates each year and that had you known you needed to take more money from your business to qualify for the Essential Plan in 2017 you would have. Since your testimony indicates that the amount you entered your January 3, 2017 application was correct based on the available information at the time, NYSOH correctly determined your annual household income to be \$15,979.00, and the eligibility determination relied upon this information.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since \$15,979.00 is 134.50% of the 2016 FPL, NYSOH properly found you to be eligible for Medicaid on an expected annual income basis.

The second issue under review is whether NYSOH properly determined that you were ineligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$15,979.00 is 134.50% of the 2016 FPL, NYSOH properly found you to be ineligible for the Essential Plan, based on the information you provided in your January 3, 2017 application.

Since the January 4, 2017 eligibility determination properly stated that, based on the information you provided, you were remained eligible for Medicaid and ineligible for the Essential Plan, it is correct and is AFFIRMED.

## **Decision**

The January 4, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You were properly determined eligible for Medicaid.

You were properly determined ineligible for the Essential Plan.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
