## NOTICE OF DISMISSAL

On January 7, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible for a tax credit of up to \$285.00 per month and, if you selected a silver-level plan, eligible for cost-sharing reductions, effective February 1, 2017. You appealed this determination insofar as you were seeking to be found eligible for the Essential Plan.

On March 8, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 5, 2017, at 10:00 a.m.

A Hearing Officer called you at 10:00 a.m. on April 5, 2017. Although you answered the call, you stated you no longer wanted to proceed with the hearing since you had already obtained health insurance outside of NYSOH. The Hearing Officer asked to swear you in to obtain a formal withdrawal. You stated that you did not wish to be sworn in, and to just cancel the hearing.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

### **How does this Dismissal Affect My Eligibility?**

The Appeals Unit of NYSOH will not review your appeal at this time.

## **If You Think Your Appeal Should Not Be Dismissed**

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
