NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On December 30, 2016, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to purchase a qualified health plan at full cost, and your children were eligible for Child Health Plus at full cost, effective February 1, 2017. You appealed that determination.

On April 3, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated that you were no longer interested in pursuing your appeal because your child had incurred \$150.00 in medical expenses during the gap in coverage your household experienced in the month of January, 2017. You testified you would not want to be responsible for premium payments if you were successful in the hearing.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

How does this Dismissal Affect Your Eligibility?

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
