## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible for the Essential Plan?

Did NYSOH properly determine that you were not eligible for Medicaid?

## Procedural History

On December 2, 2016, an application for financial assistance was run on your behalf.

On December 3, 2016, NYSOH issued a renewal stating that you were eligible for the Essential Plan, effective February 1, 2017. The notice stated this determination was based on data sources, which showed that your income was between \$17,820.00 and \$23,760.00.

On January 6, 2017, you spoke to NYSOH's Account Review Unit and appealed your eligibility insofar as you were not determined eligible for Medicaid. That day, you also requested Aid to Continue pending the outcome on your appeal.

On January 10, 2017, NYSOH issued a notice advising you that you were eligible for Medicaid through NYSOH for a limited time, this was because you had been granted Aid to Continue until a decision is made on your appeal.

On April 6, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open up to April 21, 2017, to allow you to submit supporting documents regarding your income in December 2016.

On April 20, 2017, NYSOH received the requested documentation and it was incorporated into the record as Appellant's Exhibit #1. The record was closed that day.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The December 3, 2016 renewal notice listed an income between \$17,820.00 and \$23,760.00. You testified that this is correct.
- 4) You testified that you earn \$360.00 per week, and that your expected annual income for 2017 is just over \$18,000.00.
- 5) You provided documentation from your employer that your monthly income for December 2016 was \$1,800.00, and that you earn \$360.00 each week. This yields an annual income of approximately \$18,720.00.
- 6) You testified that you may be taking a student loan interest deduction, but your application states that you will not be taking any deductions on your 2017 tax return.
- 7) Your application states that you live in Queens County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal

poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL "for the applicable budget period used to determine an individual's eligibility" (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size

(42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

## **Legal Analysis**

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan, effective February 1, 2017.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

The December 3, 2016 renewal notice listed an income between \$17,820.00 and \$23,760.00. You testified that this is correct, and submitted documentation that supports an annual household income of \$18,720.00.

The Essential Plan is provided through NYSOH for \$20.00 a month to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 150% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$18,720.00 is 157.58% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan for \$20.00.

The second issue is whether NYSOH properly determined that you were not eligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since \$18,720.00 is 157.58% of the 2016 FPL, NYSOH properly found you to be not eligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You submitted a letter from your employer which states that in December 2016 you earned \$1,800.00.

To be eligible for Medicaid, you would need to meet the non-financial criteria and have an income no greater than 138% of the FPL, which is \$1,367.00 per month. Since the documentation you provided shows that you earned \$1,800.00 in

December 2016 you do not qualify for Medicaid based on monthly income as of the date of your application.

Since the December 3, 2016 renewal notice properly stated that, based on the information available, you were eligible for the Essential Plan and not eligible for Medicaid, it is correct and is AFFIRMED.

You testified that you plan to take student loan deductions when you file your federal income tax return. Your account does not currently reflect that you intend to take any deductions on your federal tax return. If your account is not correct, please update your account accordingly.

## **Decision**

The December 3, 2016 renewal notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You were properly determined eligible for the Essential Plan.

You were properly determined not eligible for Medicaid.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
