Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive up to \$245.00 per month in advance payments of the premium tax credit, effective February 1, 2017?

Did NYSOH properly determine that you were eligible for cost-sharing reductions?

Did NYSOH properly determine that you were not eligible for the Essential Plan?

Procedural History

On November 17, 2016, NYSOH issued an eligibility determination notice based on the information contained in the November 16, 2016 application. The notice stated that you were eligible to enroll in the Essential Plan for a limited time, effective January 1, 2017. Your eligibility was conditional pending receipt of income documentation by February 14, 2017.

Also on November 17, 2016, NYSOH issued an enrollment notice confirming your selection of an Essential Plan as of November 16, 2016. The notice stated that your Essential Plan coverage would begin effective January 1, 2017.

On December 6, 2016, NYSOH received four earnings statements issued to you by your employer, [REDACTED] between November 4, 2016 and November 25, 2016.

On December 21, 2016, your eligibility was rerun by NYSOH based on an increase of your annual household income from \$31,434.00 to \$35,410.57.

On December 22, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to receive up to \$245.00 per month in advance premium tax credits (APTC) and eligible to receive cost-sharing reductions (CSR) if you enrolled in a silver level qualified health plan, February 1, 2017. That notice also stated that you were not eligible for the Essential Plan because your income was over the allowable income limits for that program.

On January 9, 2017, you spoke to NYSOH's Account Review Unit and appealed that you were found ineligible for the Essential Plan.

On April 17, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of head of household. You will claim your child as a dependent on that tax return.
- 2) You are seeking insurance for yourself only since your child had been found eligible for Child Health Plus.
- 3) The application that was submitted on November 16, 2016 listed annual household income of \$31,434.00, consisting of solely of income you receive from your employment. You testified that this amount was correct.
- 4) In response to NYSOH request for additional income documentation by February 14, 2017, you provided to NYSOH four earnings statements issued to you by your employer, [REDACTED] reflecting that you received: (1) \$584.77 on November 4, 2016, (2) \$756.75 on November 10, 2016, (3) \$687.96 on November 18, 2016 and (4) \$694.41 on November 25, 2016.
- 5) Your eligibility was redetermined by NYSOH on December 21, 2016 based on an annual household income of \$35,410.57.

- 6) Your application reflects that you will not be taking any deductions on your 2016 tax return.
- 7) You live in [REDACTED], New York.
- 8) You testified that the increase cost of purchasing a qualified health plan through NYSOH, even after applying the full APTC of \$245.00 per month, makes health insurance through NYSOH unaffordable to you. You further testified that you were seeking a reinstatement of your Essential Plan as of January 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Federal Register 4036).

For annual household income in the range of at least 200% but less than 250% of the 2016 FPL, the expected contribution is between 6.43% and 8.21% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$16,020.00 for a two-person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

Legal Analysis

The first issue is whether NYSOH properly determined that you were found eligible for an APTC of up to \$245.00 per month.

The application that was submitted on November 16, 2016 listed an annual household income of \$31,434.00. Based on the information contained in this application, you were found eligible for the Essential Plan for a limited time, pending the receipt of income documentation by February 14, 2017.

On December 6, 2016, you provided to NYSOH four earnings statements issued to you by your employer, [REDACTED], reflecting that you received: (1) \$584.77 on November 4, 2016, (2) \$756.75 on November 10, 2016, (3) \$687.96 on November 18, 2016 and (4) \$694.41 on November 25, 2016.

Based on these earnings statements, NYSOH determined that your annual household income was more accurately reflected as \$35,410.57, which was based on a total monthly earning amount of \$2,723.89, divided by four to determine your average weekly earnings, then multiplied by 52 weeks. The eligibility determination relied upon that information.

You are in a two-person household. You expect to file your 2017 income taxes as head of household and will claim your child as a dependent on that tax return.

You reside in [REDACTED], where the second lowest cost silver plan available for an individual through NYSOH costs \$456.46 per month.

An annual income of \$34,410.57 is 221.04% of the 2016 FPL for a two-person household. At 221.04% of the FPL, the expected contribution to the cost of the health insurance premium is 7.18% of income, or \$211.87 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$456.46 per month) minus your expected contribution (\$211.87 per month), which equals \$244.59 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$245.00 per month in APTC.

The second issue is whether you were properly found eligible for CSR.

CSR is available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$34,410.57 is 221.04% of the applicable FPL, NYSOH correctly found you to be eligible for cost sharing reductions.

The third issue under review is whether NYSOH properly determined that you were not eligible for the Essential Plan.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$16,020.00 for a two-person household. Since an annual household income of \$34,410.57 is 221.04% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

Since the December 22, 2016 eligibility determination properly stated that, based on the information you provided, you were eligible for up to \$245.00 per month in APTC, eligible for cost-sharing reductions, and ineligible for the Essential Plan, it is correct and is AFFIRMED.

Decision

The December 22, 2016 eligibility determination notice is AFFIRMED.

At the sole authority of NYSOH Appeals Unit, you are awarded a special enrollment period to select a qualified health plan. You have 60 days from the date of this decision in which to select a plan for your coverage for the remainder of 2017 plan year.

How this Decision Affects Your Eligibility

You remain eligible for an APTC of up to \$245.00 per month and, if you select a silver-level plan, eligible for CSR.

You are not eligible for the Essential Plan.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

You are not eligible for the Essential Plan.
