Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible for the Essential Plan, effective February 1, 2017?

Did NYSOH properly determine that you were not eligible for Medicaid?

Procedural History

On January 4, 2017, you submitted an application for financial assistance.

On January 5, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible for the Essential Plan for a limited time, effective February 1, 2017. That notice also stated that you were not eligible for Medicaid because your income was over the allowable income limit for that program. You were directed to produce income documentation by April 4, 2017.

On January 9, 2017, you spoke to NYSOH's Account Review Unit and appealed your eligibility, insofar as you were determined ineligible for Medicaid.

On April 6, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and held open to April 21, 2017, to allow you to submit supporting documents.

On April 19, 2017, you faxed documentation regarding your unemployment benefits, and an undated paystub. These documents were incorporated into the record as Appellant's Exhibit #1 and the record was closed that day.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on January 4, 2017 listed an annual household income of \$17,800.00. You testified that this amount was incorrect, because you are currently unemployed. You testified that you gave NYSOH your household income from 2016 because you did not know what you would be earning in 2017.
- 4) You testified that you have been unemployed since January 12, 2017.
- 5) You testified that you received one paycheck in January 2017.
- 6) On April 19, 2017, you submitted what appears to be a paycheck, but it does not contain an employer name or check date. There is no indication that this is the paycheck you received in January 2017.
- 7) You testified that you began receiving unemployment benefits in February or March 2017.
- 8) On April 19, 2017, you provided documentation regarding unemployment benefits you received. According to the documentation, you have been receiving unemployment benefits since March 5, 2017, in the amount of \$221.00 a week. This yields a monthly income for March 2017 of \$884.00 (Doc ID # [REDACTED]).
- 9) A letter dated April 19, 2017 from the New York State Department of Labor states that the last date a benefit was issued was April 18, 2017.
- 10) Your application states that you will not be taking any deductions on your 2017 tax return.
- 11) Your application states that you live in Bronx County.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036.).

A person who has a household income that is at or below 150% of the FPL has a \$0.00 premium contribution (New York's Basic Health Plan Blueprint, p. 21, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>).

A person who has a household income greater than 150% of the FPL or below 200% of the FPL has a \$20.00 per month premium contribution (New York's Basic Health Plan Blueprint, as approved January 2016).

The Essential Plan is considered minimum essential coverage therefore, a person who is eligible for the Essential Plan is not eligible for any premium tax credit because they are eligible for minimum essential coverage through the individual market (see 26 CFR § 1.36B-2(c)(1), 26 USC § 5000A(f)(1)(C)).

Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified

adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

Financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size (42 CFR § 435.603(h)(1); State Plan Amendment (SPA) 13-0055-MM3, as approved March 19, 2014).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for the Essential Plan for a limited time, effective February 1, 2017.

You are in a one-person household. You expect to file your 2017 income taxes as single and will claim no dependents on that tax return.

The application that was submitted on January 4, 2017 listed an annual household income of \$17,800.00 and the eligibility determination relied upon that information.

The Essential Plan is provided through NYSOH to individuals who meet the non-financial requirements and have a household modified adjusted gross income that is between 138% and 200% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since an annual household income of \$17,800.00 is 149.83% of the 2016 FPL, NYSOH properly found you to be eligible for the Essential Plan.

The second issue is whether NYSOH properly determined that you were ineligible for Medicaid.

Medicaid can be provided through NYSOH to adults between the ages of 19 and 65 who meet the non-financial requirements and have a household modified adjusted gross income that is at or below 138% of the FPL for the applicable family size. On the date of your application, the relevant FPL was \$11,800.00 for a one-person household. Since \$17,800.00 is 149.83% of the 2016 FPL, NYSOH properly found you to be ineligible for Medicaid on an expected annual income basis, using the information provided in your application.

However, financial eligibility for Medicaid for applicants who are not currently receiving Medicaid benefits is based on current monthly household income and family size.

You testified that you have been unemployed since January 12, 2017 and that you received one paycheck in January 2017. On April 19, 2017, you submitted what appears to be a paycheck, but it does not contain an employer name or check date. There is no indication that this is the paycheck you received in January 2017.

Since you did not provide sufficient income documentation to prove your earnings in January 2017, NYSOH Appeals Unit cannot properly decide if NYSOH was correct in denying you Medicaid as of January 1, 2017.

Since the January 5, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for the Essential Plan and ineligible for Medicaid, it is correct and is AFFIRMED.

However, you did provide sufficient documentation to show that you have been receiving unemployment benefits since March 5, 2017 in the amount of \$221.00 a week, which yields a monthly income of \$884.00 for March 2017. Therefore, your case is RETURNED to redetermine your eligibility as of March 1, 2017 (Doc ID # [REDACTED]).

Decision

The January 5, 2017 eligibility determination notice is AFFIRMED.

Your case is RETURNED to NYSOH to redetermine your eligibility as of March 1, 2017, using a household size of one person and a monthly income of \$884.00 (Doc ID # [REDACTED]).

How this Decision Affects Your Eligibility

You were properly determined eligible for the Essential Plan.

You were properly determined ineligible for Medicaid.

Your case is being sent back to determine your eligibility as of March 1, 2017 based on the income documentation you submitted.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).

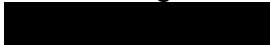
