## Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) provide you with a timely determination of your Medicaid eligibility as of January 1, 2017?

Did NYSOH properly determine that your enrollment in your Medicaid Managed Care plan was effective February 1, 2017?

## Procedural History

On December 3, 2016, NYSOH issued a renewal notice stating that there was insufficient information based on state and federal sources to determine whether you qualified for financial help paying for your health coverage and to update your account by January 15, 2017.

On December 15, 2016, you updated your NYSOH account.

On December 16, 2016, NYSOH issued a notice stating that the income information in your application did not match what NYSOH received from state and federal sources. You were directed to provide income documentation by December 30, 2016.

Also, on December 16, 2016, NYSOH issued a disenrollment notice stating that your coverage in your Medicaid Managed Care plan was ending effective December 31, 2016.

On January 5, 2017, NYSOH issued a notice of eligibility determination, based on a January 4, 2017 system run, stating that you were eligible for Medicaid, effective February 1, 2017.

On January 6, 2017, NYSOH issued a notice of enrollment based on a plan selection on January 5, 2017, stating that you were enrolled in a Medicaid Managed Care plan, and that your coverage would start on February 1, 2017.

On January 10, 2017, you spoke to NYSOH's Account Review Unit and appealed the start date of your enrollment in your Medicaid Managed Care plan, insofar as it did not begin January 1, 2017.

On April 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) NYSOH's December 3, 2016 renewal notice directed you to provide income documentation by January 15, 2017.
- 2) On December 15, 2016, you uploaded your 2015 tax return to your NYSOH account (██████████).
- 3) Also on December 15, 2016, you uploaded a personal attestation stating that you currently did not have any source of income (██████████).
- 4) NYSOH records reflect that your 2015 tax return was verified on January 4, 2017.
- 5) NYSOH records reflect that you were determined eligible for Medicaid effective February 1, 2017.
- 6) The record reflects that a Medicaid Managed Care Plan was selected on January 4, 2017, and that your enrollment was effective February 1, 2017.
- 7) NYSOH records reflect and you testified that you were retroactively granted Medicaid Fee-for-Service coverage for the month of January 2017.
- 8) You testified that you want your Medicaid Managed Care plan to begin on January 1, 2017 because NYSOH incorrectly determined that you were not eligible for a Medicaid Managed Care plan for the month of January 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Medicaid Renewal

In general, NYSOH must review Medicaid eligibility once every 12 months or “whenever it receives information about a change in a beneficiary’s circumstances that may affect eligibility” (42 CFR § 435.916(a)(1), (d)). NYSOH must make its “redetermination of eligibility without requiring information from the individual if able to do so based on reliable information contained in the individual's account or other more current information available to the agency, including but not limited to information accessed through any data bases accessed by the agency” (42 CFR § 435.916(a)(2)).

NYSOH must provide an individual with the annual redetermination notice, including the projected eligibility for coverage and financial assistance, and must require the qualified individual to report any changes within 30 days (45 CFR § 155.335(c), (e)). Once the 30-day period has lapsed, NYSOH must issue a redetermination as provided by the notice, with consideration given to any updates that may have been provided by the individual (45 CFR § 155.335(h)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13 ADM-03(III)(F)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H(6)(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; NY Social Services Law § 364-j(1)(c); 18 NYCRR § 360-10.3(h); Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010, 13 ADM-03(III)(F)).

### Verification Process

For all individuals whose income is needed to calculate the household’s eligibility, NYSOH must request data that will allow NYSOH to verify the household’s income (45 CFR § 155.320(c)(1)(i), 42 CFR § 435.945).

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the

opportunity to submit satisfactory documentary evidence (45 CFR §155.315(f) 42 CFR § 435.952).

### Timely Notice of Medicaid Eligibility

When an individual applies for insurance through NYSOH, NYSOH must determine that person's eligibility promptly and without undue delay (45 CFR § 155.310(e)(1); 42 CFR § 435.1200(b)(3)(iii)).

To assess whether an eligibility determination was untimely, NYSOH must base the time period from the date of application to the date NYSOH notifies the applicant of its decision (45 CFR § 155.310(e)(2)). However, if the applicant submits an incomplete application or there is not sufficient information for NYSOH to make an eligibility determination, then NYSOH must notify that applicant that more information is needed to complete the application (45 CFR § 155.310(k)(1)).

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the application (42 CFR § 435.912).

## **Legal Analysis**

The first issue is whether NYSOH's provided you with a timely determination of your Medicaid eligibility as of January 1, 2017.

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data that will allow NYSOH to verify the household's income.

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence.

You updated your account on December 15, 2016. The income amount that was entered into this application did not match federal and state data sources. As a result, NYSOH asked that you submit additional documentation to confirm your income.

Also on December 15, 2016, you uploaded your 2015 tax return as proof of your income to your NYSOH account. On January 4, 2017, NYSOH verified your 2015 tax return as acceptable proof of income.

Therefore, your application was considered complete as of January 4, 2017 for purposes of issuing an eligibility determination.

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the completed application. To assess whether an eligibility determination was untimely, NYSOH must base the time-period from the date of the completed application to the date NYSOH notifies the applicant of its decision.

NYSOH issued an eligibility determination notice on January 5, 2017 that stated you were eligible for Medicaid effective February 1, 2017. Since NYSOH issued an eligibility determination one day from the date your application was considered complete, the January 5, 2017 eligibility determination was timely.

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month.

Since your application was complete as of January 4, 2017, NYSOH's January 5, 2017 eligibility determination should have found you eligible for Medicaid effective January 1, 2017.

However, NYSOH records reflect and you testified that you were retroactively granted Medicaid Fee-for-Service coverage for the month of January 2017. Therefore, NYSOH correctly provided you with Medicaid fee-for-service coverage for the month of January 2017.

The second issue under review is whether NYSOH properly determined that your enrollment in a Medicaid Managed Care plan was effective February 1, 2017.

NYSOH records reflect that your application was complete on January 4, 2017 and on January 5, 2017, you were enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a plan is selected for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

On January 5, 2017, a Medicaid Managed Care plan was selected, so it properly took effect on the first day of the following month; that is, on February 1, 2017.

Therefore, the January 6, 2017 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective February 1, 2017, was correct and must be AFFIRMED.

## **Decision**

The January 6, 2017 enrollment confirmation notice is AFFIRMED.

NYSOH provided you with a timely determination of your Medicaid eligibility as of January 1, 2017.

## **How this Decision Affects Your Eligibility**

This decision does not change your eligibility.

The effective date of your Medicaid Managed Care plan is February 1, 2017.

NYSOH provided you with a timely determination of your Medicaid eligibility as of January 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
