Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your child's eligibility for and enrollment in Child Health Plus terminated effective December 31, 2016?

Procedural History

On September 12, 2016, your child was added to your NYSOH account and an application was submitted on his behalf.

On September 13, 2016, NYSOH issued an eligibility determination notice stating that your child was conditionally eligible to enroll in Child Health Plus effective October 1, 2016. The notice requested that you provide documentation confirming his citizenship status and Social Security Number before December 11, 2016.

Also on September 13, 2016, NYSOH issued an enrollment notice confirming your child's enrollment in a Child Health Plus plan, effective October 1, 2016.

On December 19, 2016, NYSOH issued an eligibility redetermination notice stating that your child was not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. He also could not enroll in a qualified health plan at full cost because you had not confirmed his citizenship status and provided his Social Security Number within the required timeframe.

Also on December 19, 2016, NYSOH issued a disenrollment notice stating that your child's coverage in his Child Health Plus plan would end effective December 31, 2016 because he was no longer eligible to enroll in health insurance through NYSOH.

On December 27, 2017, your child's Social Security Number was added to your NYSOH account.

On December 28, 2016, NYSOH issued an eligibility redetermination notice stating that your child was eligible to enroll in Child Health Plus, effective February 1, 2017.

Also on December 28, 2016, NYSOH issued an enrollment confirmation notice stating that your child was enrolled in a Child Health Plus plan.

On January 11, 2017, you spoke to NYSOH's Account Review Unit and appealed your child's disenrollment from his Child Health Plus plan for the month of January 2017.

On April 4, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you are only appealing your child's disenrollment from his Child Health Plus plan for the month of January 2017.
- 2) The record indicates that your child was added to your NYSOH account on September 12, 2016. The application that was submitted that day indicates that he was a U.S Citizen but he did not have a Social Security Number because you were in the process of applying for one.
- 3) You testified that you did not know your child was about to be disenrolled from his Child Health Plus plan until you received the December 19, 2016 disenrollment notice on or about Christmas Day 2016. You called NYSOH to rectify the situation immediately after receiving the letter.
- 4) According to your NYSOH account, your child's Social Security Number was added to your NYSOH account on December 27, 2016.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Child Health Plus

A child who meets the eligibility requirements for Child Health Plus may be eligible to receive a subsidy payment if the child resides in a household with a household income at or below 400% of the federal poverty level (FPL) (New York Public Health Law (PHL) § 2511(2)(a)(iii)).

To be eligible for Child Health Plus, the child:

- Must be under 19 years of age;
- Must be a New York State Resident;
- Must not have other health insurance coverage; and
- Must not be eligible for, or enrolled in, Medicaid

(N.Y. Pub. Health Law. § 2511(2)(a)-(e)).

As a condition of eligibility for Child Health Plus, an individual, including children, must furnish their Social Security Number and evidence of their citizenship or status as a qualified immigrant or PRUCOL alien to NY State of Health for verification purposes (42 CFR § 435.910(a) and (b)(3); 42 CFR § 457.340(b); 18 NYCRR § 360-3.2(j)(2) and (3); see *generally* 18 NYCRR § 360-3.2(j)).

NYSOH must require an applicant who has a Social Security Number to provide the number but does not require an applicant's Social Security Number as a condition of enrollment for Child Health Plus if the applicant is not eligible to receive one or his or her number is not yet available (42 CFR § 457.340(b), 42 CFR § 435.910(h)(1); Model State Children's Health Insurance Program Plan, Section 4.1.9).

If an applicant attests to citizenship, status as a national, or lawful presence, and NYSOH is unable to verify such attestation, NY State of Health must then provide the applicant with 90 days to provide satisfactory documentary evidence. Notice is considered received 5 days after the date on the notice, unless the applicant demonstrates that he or she did not receive the notice within the 5-day period (45 CFR § 155.315(c)(3), (f)(2)(i)).

If NYSOH remains unable to verify the citizenship attestation after the 90-day period ends, it must determine the applicant's eligibility based on the information available (45 CFR § 155.315(f)(5)).

NYSOH is required to provide proper written notice to an applicant of any decision effecting an enrollee's Child Health Plus eligibility (42 CFR § 457.340(e)). When Child Health Plus coverage is denied, suspended or terminated NYSOH must provide sufficient notice to enable the child's parent or caretaker relative to take appropriate actions to allow Child Health Plus coverage to continue without interruption (42 CFR § 457.340(e)(2); 42 CFR § 457.1130(a)(3)).

The State of New York has if a child's period of eligibility for Child Health Plus begins on the first day of the month during which a child is eligible. A child will become eligible on the first day of the next month, if the application is received by the 15th of the month; applications received after the 15th day of the month will be processed for the first day of the second following month (see State Plan Amendment (SPA) NY-14-0005, approved February 3, 2015 and effective January 1, 2014).

Legal Analysis

The issue under review is whether NYSOH properly determined that your child's eligibility for and enrollment in Child Health Plus terminated effective December 31, 2016.

NYSOH is required to determine whether individuals are eligible to enroll in coverage through NYSOH, and must confirm, among other things, their citizenship status and Social Security Number.

If NYSOH cannot verify an individual's citizenship status or Social Security Number, it must provide the individual with notice of the inconsistency. NYSOH must then provide the individual with a period of 90 days from the date notice is received to resolve the inconsistency.

Your child was added to your NYSOH account on September 12, 2016. The application that was submitted that day indicates that he was a U.S Citizen but he did not have a Social Security Number because you were in the process of applying for one.

In the eligibility determination issued on September 13, 2016 you were advised that your child's eligibility for Child Health Plus was only conditional, and that you needed to confirm his citizenship status and Social Security Number before December 11, 2016.

On December 19, 2016, NYSOH issued a disenrollment notice stating that your child's coverage in his Child Health Plus plan would end effective December 31, 2016 because he was no longer eligible to enroll in health insurance through NYSOH. According to the eligibility determination issued on that day, this was

because NYSOH did not receive documentation of his citizenship status and Social Security Number by the deadline.

When NYSOH denies, terminates, or suspends a child's Child Health Plus coverage, they are required to provide sufficient notice so that a child's parent can take action to prevent a gap in coverage for the child. Notice is considered received five days after the date on the notice. In this case, the notice formally disenrolling your child from her Child Health Plus plan was dated December 19, 2016. Therefore, the notice terminating your child's enrollment would be considered received as of December 24, 2016.

When changes are made to an individual's application after the 15th of any month, NYSOH must make the redetermination that results from a change effective the first day of the next following month. Since you would have received NYSOH's notice terminating your child's Child Health Plus eligibility after the 15th of the month, any changes you would have made to your account to prevent a gap in coverage would not have been effective until February 1, 2017.

Therefore, NYSOH failed to provide you with sufficient notice that would have allowed you to take action to prevent a gap in your child's Child Health Plus coverage for the month of January 2017 and, as such, the December 19, 2016 eligibility redetermination and disenrollment notices are RESCINDED.

Decision

The December 19, 2016 eligibility redetermination and disenrollment notices are RESCINDED.

Your case is RETURNED to NYSOH to reinstate your child into his Child Health Plus plan for the month of January 2017, and to notify you accordingly.

How this Decision Affects Your Eligibility

Your child should not have been terminated from his Child Health Plus plan in December 2016 for failure to submit proof of his citizenship status and Social Security Number because NYSPH failed to provide you with sufficient notice to take action to prevent a gap in his Child Health Plus coverage for the month of January 2017.

Your case is being sent back to NYSOH to reinstate your child into his Child Health Plus plan for the month of January 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
