Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your children's enrollment in a Medicaid Managed Care (MMC) plan terminated effective January 31, 2017?

Procedural History

On September 24, 2016, NYSOH issued an eligibility determination notice stating that you and your two children were eligible for Medicaid, effective September 1, 2016.

On September 28, 2016, NYSOH issued a notice of enrollment confirming your, and your children's, enrollment in an MMC plan, with a plan enrollment start date of November 1, 2016.

On January 4, 2017, NYSOH redetermined your household's eligibility for financial assistance with health insurance.

On January 5, 2017, NYSOH issued a notice of eligibility redetermination stating that you would remain eligible for Medicaid, effective January 1, 2017, and your children would remain eligible for Medicaid, effective February 1, 2017. However, your children were unable to select an MMC plan, as the system was showing that they had other full benefit health insurance or Medicare.

Also, on January 5, 2017, NYSOH issued a disenrollment notice stating that your children's enrollment in their MMC plan would end, effective January 31, 2017, because records showed that they had other health insurance or Medicare.

On January 11, 2017, you spoke to NYSOH's Account Review Unit and appealed the disenrollment of your children from their MMC plan coverage.

On April 6, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and your account confirms, that you and your children were determined eligible for Medicaid, effective September 1, 2016.
- 2) Your NYSOH account reflects that you selected an MMC plan on September 26, 2016, and your, and your children's, enrollment in that plan began on November 1, 2016.
- 3) Your NYSOH account reflects that your children were disenrolled from their MMC coverage, effective January 31, 2017, because NYSOH detected that they had other full benefit health insurance or Medicare.
- 4) You testified that your children have health insurance coverage through a plan that their father pays for, pursuant to a divorce decree from 2012.
- 5) You testified that you are responsible for a \$1,500.00 deductible and 20% in-network co-insurance after that.
- 6) You testified that these costs are unaffordable, so you are looking for other coverage to supplement the coverage your children have through their father.
- 7) You testified that your children had Medicaid coverage in well and were also able to have a managed care plan, so you did not think that there would be any issue with their eligibility for an MMC plan in New York.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

<u>Medicaid</u>

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the federal poverty level (FPL) for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

A child who is at least one year of age, but younger than nineteen, is eligible for Medicaid if he or she meets the non-financial criteria and has a household modified adjusted gross income that falls at or below 154% of the FPL for the applicable family size (42 CFR § 435.118(c); New York State Department of Social Services Administrative Directive 13 OHIP/ADM-03).

Third Party Health Insurance

A person who has primary medical or health care coverage available from or under a third-party insurance provider is not permitted to enroll into a Medicaid Managed Care plan (NY SSL § 364-j(3)(e)(xx); Medicaid Managed Care Model Contract (Appendix H-17), effective 3/1/2014 – 2/28/2019). However, they will remain eligible for fee-for-service Medicaid with limited exceptions, including entering prison or another facility that provides medical care, lack of state residence, or failing to provide a valid social security number (NY SSL § 366(4)(c)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your children's enrollment in their MMC plan was terminated, effective January 31, 2017.

In the September 24, 2016 notice of eligibility determination, you and your children were found eligible for Medicaid, effective September 1, 2016. On September 26, 2016, you selected an MMC plan, effective November 1, 2016, as documented by the September 28, 2016 notice of enrollment confirmation.

Generally, when an individual is eligible for Medicaid through NYSOH they are required to enroll in an MMC plan. Applicants determined eligible will be enrolled or remain in their Medicaid plan with limited exceptions, including entering prison

or another facility that provides medical care, moving out of state, or failing to provide a valid Social Security number.

On January 4, 2017, NYSOH redetermined your household's eligibility for financial assistance with health insurance. On January 5 2017, NYSOH issued a disenrollment notice advising that your children's coverage in your MMC plan would be terminated as of January 31, 2017 because they had full benefit health insurance or Medicare.

When NYSOH determines that a person has active coverage in a health insurance plan outside of NYSOH, that person is not eligible to enroll, or remain enrolled, in an MMC plan.

You testified that your children have health insurance coverage through their father's health insurance, as mandated by a 2012 divorce decree, but that you are responsible for the deductible, coinsurance, and any other costs after their father pays the premium. You testified that these costs are not affordable, which is why you are looking for your children to be eligible for enrollment in an MMC plan.

Though your testimony was credible, individuals with active third-party health insurance are not eligible for enrollment in an MMC plan in New York State.

Accordingly, the January 5, 2017 disenrollment notice terminating your children's coverage under your MMC plan, effective January 31, 2017, is AFFIRMED.

Decision

The January 5, 2017 disenrollment notice is AFFIRMED.

How this Decision Affects Your Eligibility

Your children are not eligible to enroll in an MMC plan because they have active third-party health insurance coverage.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.
