#### Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in a qualified health plan was effective February 1, 2017?

# **Procedural History**

On January 12, 2017, you submitted a non-financial application to NYSOH.

Also on January 12, 2017, NYSOH made a preliminary determination that you were eligible to purchase a qualified health plan at full cost, effective February 1, 2017.

That same day, you spoke to NYSOH's Account Review Unit and appealed the eligibility determination insofar as it began your eligibility and enrollment in a qualified health plan on February 1, 2017, and not January 1, 2017.

On January 13, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to purchase a qualified health plan, effective February 1, 2017.

Also on January 13, 2017, NYSOH issued a notice confirming your enrollment in a qualified health plan, effective February 1, 2017.

On April 21, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) You testified that you previously had private health insurance coverage through Oxford Metro Plan for approximately fourteen years.
- 2) You testified that you were advised by your pharmacist on that you did not have health insurance coverage.
- 3) You testified that you contacted your insurance carrier Oxford Metro Plan, which advised you that your coverage had ended on December 31, 2016 and that they had notified you of this fact in writing.
- 4) You testified that you did not receive any notice from Oxford Metro Plan that your coverage was ending on December 31, 2016.
- You testified that you were advised by Oxford Metro Plan that the plan was discontinued and that you needed to apply for health coverage through NYSOH.
- 6) You submitted a non-financial application to NYSOH on January 12, 2017.
- 7) You testified, and the record reflects, that you selected a qualified health plan on January 12, 2017.
- 8) Your enrollment in the plan became effective February 1, 2017.
- You testified that you did not incur any medical costs during the month of January 2017.
- 10) You testified that you want your qualified health plan to begin on January 1, 2017 because you were concerned that your lack of health insurance coverage for the month of January 2017 could negatively affect your eligibility for health insurance in the future.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

# **Applicable Law and Regulations**

#### Enrollment in a Qualified Health Plan

The effective date of coverage by a qualified health plan is determined by the date on which an applicant selects a plan for enrollment. For individuals who are eligible for enrollment, NYSOH must generally ensure that coverage is effective the first day of the following month for selections received by NYSOH from the first to the fifteenth of any month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(i)). For selections received by NYSOH from the sixteenth to the last day of any month, NYSOH must ensure coverage is effective the first day of the second following month (45 CFR §§ 155.410(f)(2), 155.420(b)(1)(ii)).

## Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in a qualified health plan was effective February 1, 2017.

The record shows that on January 12, 2017, you submitted a non-financial application to NYSOH. You testified, and the record reflects, that you also selected a qualified health plan on January 12, 2017. On January 13, 2017, NYSOH issued an enrollment confirmation notice stating that your enrollment in your qualified health plan was effective February 1, 2017.

The date on which a qualified health plan can take effect depends on the day a person selects the plan for enrollment. A plan that is selected from the first day to and including fifteenth day of a month goes into effect on the first day of the following month.

Therefore, NYSOH's January 13, 2017 eligibility determination notice and enrollment confirmation notices are AFFIRMED because they properly began your enrollment in your qualified health plan on February 1, 2017.

You testified that your previous insurance carrier, Oxford Metro Plan, did not provide you with notice that your insurance coverage would be ending effective December 31, 2016. The NYSOH Appeals Unit's jurisdiction is limited to the review of determinations made by NYSOH, and cannot review determinations made by private insurance carriers.

#### **Decision**

The January 13, 2017 eligibility determination notice is AFFIRMED.

The January 13, 2017 enrollment confirmation notice is AFFIRMED.

## If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
