Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your enrollment in your Medicaid Managed Care plan ended effective December 31, 2016?

Procedural History

On November 22, 2015 NYSOH issued a notice of eligibility determination stating that you were eligible for Medicaid effective January 1, 2016.

You then enrolled in a Medicaid Managed Care plan effective January 1, 2016.

On October 13, 2016, NYSOH issued a notice that it was time to renew your health insurance for 2016. That notice stated that, based on information from federal and state sources, NYSOH could not make a decision about whether you would qualify for financial help paying for your health coverage, and that you needed to update your account by December 15, 2016 or you might lose the financial assistance you were currently receiving.

No updates were made to your account by December 15, 2016.

On December 19, 2016, NYSOH issued an eligibility determination notice stating that you are not eligible for Medicaid, Child Health Plus, or to receive tax credits or cost-sharing reductions to help pay for the cost of insurance. You also could not enroll in a qualified health plan at full cost. This was because you had not

responded to the renewal notice and had not completed your renewal within the required time frame. Your eligibility ended January 1, 2017.

On December 19, 2016, a disenrollment notice was issued terminating your Medicaid Managed Care plan effective December 31, 2016.

On December 27, 2016, you wrote a letter to NYSOH's Account Review Unit and appealed the disenrollment from your Medicaid Managed Care plan December 31, 2016.

On April 6, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you receive all your notices from NYSOH by regular mail.
- 2) You testified that you did not receive any notices telling you that you needed to update your application to renew your Medicaid Managed Care coverage by December 15, 2016.
- 3) You testified that you did not know that you needed to update your account until you received a disenrollment notice stating your Medicaid Managed Care plan was terminated effective December 31, 2016. You testified you believed this was the December 19, 2016 disenrollment notice.
- 4) You testified you have not moved or changed your address which you confirmed in your NYSOH account.
- 5) No notices sent to you at the address listed on your NYSOH account have been returned as undeliverable.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid Renewal

In general, NYSOH must review Medicaid eligibility once every twelve months or “whenever it receives information about a change in a beneficiary’s circumstances that may affect eligibility” (42 CFR § 435.916(a)(1), (d)). NYSOH must make its “redetermination of eligibility without requiring information from the individual if able to do so based on reliable information contained in the individual's account or other more current information available to the agency, including but not limited to information accessed through any data bases accessed by the agency” (42 CFR § 435.916(a)(2)).

NYSOH must provide an individual with the annual redetermination notice, including the projected eligibility for coverage and financial assistance, and must require the qualified individual to report any changes within 30 days (45 CFR § 155.335(c), (e)). Once the 30-day period has lapsed, NYSOH must issue a redetermination as provided by the notice, with consideration given to any updates provided by the individual (45 CFR §155.335(h)).

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b)).

Medicaid Managed Care (MMC) plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H(6)(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019, N.Y. Soc. Serv. Law §364-j(1)(c); 18 NYCRR § 360-10.3(h)).

Timely Notice Concerning Adverse Actions

Agencies which administer Medicaid benefits must give beneficiaries timely and adequate notice of proposed action to terminate, discontinue, or suspend their eligibility or to reduce or discontinue services they may receive under Medicaid (42 CFR §435.917 (a)).

Legal Analysis

The issue under review is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan ended effective December 31, 2016.

You were originally found eligible for Medicaid effective January 1, 2016.

Generally, NYSOH must redetermine a qualified individual's eligibility for Medicaid once every 12 months without requiring information from the individual

if able to do so based on reliable information contained in the individual's account or other more current information available to the agency. NYSOH's October 13, 2016 renewal notice stated that there was not enough information to determine whether you were eligible to continue your financial assistance for health insurance, and that you needed to supply additional information by December 15, 2016, or your financial assistance might end.

Because there was no timely response to this notice, you were terminated from your Medicaid Managed Care plan effective December 31, 2016.

You testified that you did not receive any notice from NYSOH telling you that you needed to update the information in your NYSOH account. You testified, and your NYSOH account confirms, that you elected to receive notifications by regular mail. However, there is no evidence in the record that any of the notices that were sent to your mailing address were returned as undeliverable.

Therefore, the record reflects that NYSOH properly notified you of your annual renewal and that information in your NYSOH account needed to be updated in order to ensure your enrollment in your health plan and eligibility for financial assistance would continue.

Therefore, NYSOH's December 19, 2016 disenrollment notice and eligibility redetermination notice was proper and is AFFIRMED.

Decision

The December 19, 2016 disenrollment notice and eligibility redetermination notice is AFFIRMED.
