Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health provide a timely determination of your Medicaid eligibility effective December 1, 2016?

Did NY State of Health properly determine that your Medicaid Managed Care plan began on January 1, 2017?

Procedural History

On October 25, 2016, NY State of Health (NYSOH) received your application for financial assistance with your health insurance. Also on this date, you uploaded a letter from your employer dated October 25, 2016 and a paystub dated May 2, 2016 to your NYSOH account.

On October 26, 2016, NYSOH issued a notice stating more information was needed to make a determination. The notice explained the income documentation you provided NYSOH did not match what was obtained from state and federal data sources. You were asked to submit income documentation for your household by November 9, 2016.

On November 5, 2016, NYSOH issued a notice requesting more income documentation to determine your eligibility because the paystub dated May 2, 2016 was invalidated. You were asked to submit more income documentation by November 24, 2016.

On November 8, 2016, you uploaded a letter from your second employer dated October 28, 2016 to your NYSOH account.

On November 21, 2016, NYSOH verified the letter from your employers you uploaded as documentation on October 25, 2016 and November 8, 2016 and a new application was submitted on your behalf on November 22, 2016.

On November 23, 2016, NYSOH issued an eligibility determination notice finding you eligible for Medicaid effective December 1, 2016.

On November 24, 2016, you selected a Medicaid Managed Care plan.

On November 25, 2016, an enrollment confirmation notice was issued confirming your selection of a Medicaid Managed Care plan on November 24, 2016. The notice confirmed your enrollment in a plan starting January 1, 2017.

On January 17, 2017, you contacted the NYSOH Account Review Unit and requested an appeal of the start date of your Medicaid Managed Care plan, requesting that it begin December 1, 2016.

On March 28, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified, and the record reflects, that you are appealing your enrollment start date of your Medicaid Managed Care plan.
- 2) According to your NYSOH account, NYSOH received your application for financial assistance on October 25, 2016. In this application, you indicated that you had two different employers: [REDACTED], and [REDACTED].
- 3) On October 25, 2016, you submitted documentation of your paystub from [REDACTED] dated May 2, 2016 and a letter from your employer, [REDACTED] dated October 25, 2016 to NYSOH for verification of the income stated in your October 25, 2016 application.
- 4) On November 4, 2016, NYSOH invalidated the submitted paystub dated May 2, 2016 from [REDACTED] because it was not from the last 30 days.

- 5) On November 8, 2016, you submitted a letter from your employer, [REDACTED] dated October 28, 2016.
- 6) On November 21, 2016, the letters from your employers were verified as acceptable proof of income.
- 7) The record reflects that you selected a Medicaid Managed Care plan on November 24, 2016.
- 8) You testified that you want your Medicaid Managed Care plan to begin on December 1, 2016 because you have medical bills from that month.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Medicaid

An individual is eligible for fee-for-service Medicaid effective on the first day of the month if an individual was eligible any time during that month (42 CFR § 435.915(b), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Medicaid Managed Care plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; see 42 USC § 1315; § 364-j(1)(c); 18 NYCRR § 360-10.3(h), Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010,13ADM-03(III)(F)).

Verification Process

For all individuals, whose income is needed to calculate the household's eligibility, NYSOH must request data from state and federal data sources that will allow NYSOH to verify the household's income (45 CFR §155.320(c)(1)(i), 42 CFR § 435.945).

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence (45 CFR §155.315(f) 42 CFR § 435.952).

Timely Notice of Medicaid Eligibility

When an individual applies for insurance through NYSOH, NYSOH must determine that person's eligibility promptly and without undue delay (45 CFR § 155.310(e)(1); 42 CFR § 435.1200(b)(3)(iii)).

To assess whether an eligibility determination was untimely, NYSOH must base the time period from the date of application to the date NYSOH notifies the applicant of its decision (45 CFR § 155.310(e)(2)). However, if the applicant submits an incomplete application or there is not sufficient information for NYSOH to make an eligibility determination, then NYSOH must notify that applicant that more information is needed to complete the application (45 CFR § 155.310(k)(1)).

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the completed application (42 CFR § 435.912).

Legal Analysis

The first issue is whether NYSOH's provided you with timely determination of your Medicaid eligibility, effective December 1, 2016.

For all individuals whose income is needed to calculate the household's eligibility, NYSOH must request data from state and federal data sources that will allow NYSOH to verify the household's income.

If NYSOH cannot verify the income information required to determine eligibility they must attempt to resolve the inconsistency including giving the applicant the opportunity to submit satisfactory documentary evidence.

You updated your NYSOH account on October 25, 2016. The income amount that was entered into this application did not match federal and state data sources. As a result, NYSOH asked that you submit additional documentation to confirm your income.

On October 25, 2016, you uploaded a copy of your paystub from [REDACTED] dated May 2, 2016 and letter from [REDACTED] dated October 25, 2016.

On November 4, 2016, NYSOH invalidated the paystub as unacceptable proof of income from [REDACTED] because it was not from the last 30 days. As a result, on November 5, 2016, NYSOH issued a notice of invalid documentation and asked that you submit more income information to confirm your eligibility by November 24, 2016.

On November 8, 2016, you uploaded a letter from [REDACTED] [REDACTED] dated October 28, 2016.

Therefore, your application was considered complete as of November 8, 2016 for purposes of issuing an eligibility determination.

NYSOH must provide Medicaid applicants notice of their eligibility determination within 45 days from the date of the completed application. To assess whether an eligibility determination was untimely, NYSOH must look at the time from the date of the completed application to the date NYSOH notifies the applicant of its decision.

NYSOH issued an eligibility determination notice on November 23, 2016 that stated you were eligible for Medicaid effective December 1, 2016. Since NYSOH issued an eligibility determination 15 days from the date your application was considered complete, the November 23, 2016 eligibility determination was timely and is AFFIRMED.

The second issue is whether NYSOH properly determined that your enrollment in your Medicaid Managed Care plan was effective January 1, 2017.

The record reflects that you contacted NYSOH on November 24, 2016 and enrolled into a Medicaid Managed Care plan.

The date on which a Medicaid Managed Care plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

Since the November 23, 2016 eligibility determination notice was timely issued, you could have selected a Medicaid Managed Care plan as of November 23, 2016. Your plan would therefore properly take effect on the first day of the second following month after November; that is, on January 1, 2017.

Therefore, the November 25, 2016 enrollment confirmation notice stating that your enrollment in your Medicaid Managed Care plan would be effective January 1, 2017, was correct and must be AFFIRMED.

Decision

The November 23, 2016 eligibility determination was timely and is AFFIRMED.

How this Decision Affects Your Eligibility

This decision does not affect your eligibility.

You are eligible for Medicaid effective December 1, 2016.

Your enrollment in your Medicaid Managed Care plan is effective January 1, 2017.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
