## Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that your, your spouse, and children's Medicaid Managed Care (MMC) plan should have a plan enrollment start date of February 1, 2017?

## Procedural History

On December 7, 2016, NYSOH issued an eligibility determination notice stating that you, your spouse, and seven eldest children were eligible for Medicaid, effective as of January 1, 2017.

On January 5, 2017, NYSOH issued an enrollment notice confirming that as of December 6, 2016, you, your spouse, and seven eldest child were enrolled in a Medicaid Managed Care (MMC) plan with an enrollment start date of February 1, 2017.

On January 18, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal insofar as your family's MMC plan enrollment start date.

On April 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Testimony was taken during the hearing, and the record was closed at the end of the hearing.

## Findings of Fact

A review of the record support the following findings of fact:

- 1) According to your NYSOH account and testimony, you submitted an application for financial assistance for you, your spouse, and seven eldest children on December 6, 2016.
- 2) You testified that you enrolled your family in a MMC on December 6, 2016 or December 12, 2016.
- 3) On January 5, 2017, NYSOH issued an enrollment notice confirming that you enrolled your family in a MMC on December 6, 2016 [REDACTED].
- 4) According to your NYSOH account and testimony, your family's MMC plan was effective February 1, 2017.
- 5) You testified that you are seeking to have your family's MMC coverage begin January 1, 2017 to cover the medical expenses that were incurred in January 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### MMC Effective Date:

MMC plan enrollments received on or before the fifteenth day of the month are effective the first day of the following month. Enrollments received after the fifteenth day of the month are effective the first day of the second following month (Medicaid Managed Care Model Contract (Appendix H-6(b)(ii) & (iii), effective 3/1/2014 – 2/28/2019; Administrative Directive 13 OHIP/ADM-03(III)(F), (Medicaid Eligibility Changes under the Affordable Care Act (ACA) of 2010)).

## **Legal Analysis**

The issue is whether NYSOH properly determined that your, your spouse, and seven eldest children's MMC enrollment should have been effective February 1, 2017.

You testified that you enrolled your family in a MMC on December 6, 2016, or December 12, 2016. Furthermore, the enrollment notice issued by NYSOH confirms that your MMC plan enrollment was selected on December 6, 2016.

The date on which a MMC plan can take effect depends on the day a person selects the plan for enrollment.

A plan that is selected from the first day to and including the fifteenth day of a month will go into effect on the first day of the following month. A plan that is selected on or after the sixteenth day of the month will go into effect on the first day of the second following month.

The available record supports that you selected your family's MMC on December 6, 2016. Therefore, your family's MMC should have begun on first day of the following month; that is, on January 1, 2017.

Therefore, the January 5, 2017, enrollment notice is MODIFIED to state that you, your spouse, and seven eldest children were enrolled in a MMC with an enrollment start date of January 1, 2017.

## **Decision**

The January 5, 2017, enrollment notice is MODIFIED to state that you, your spouse, and seven eldest children were enrolled in a MMC with an enrollment start date of January 1, 2017.

Your case is RETURNED to NYSOH to effectuate your family's coverage for the month of January 2017.

## **How this Decision Affects Your Eligibility**

You, your spouse, and seven eldest children's MMC plan enrollment start date was January 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
