NOTICE OF DISMISSAL

On January 5, 2017, NY State of Health (NYSOH) issued an enrollment notice, stating that your child's Essential Plan coverage would begin effective February 1, 2017. You appealed insofar as you were seeking for her coverage to begin no later than January 1, 2017.

On March 10, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 12, 2017, at 1:00 p.m.

A Hearing Officer called you at 1:14 p.m. on April 12, 2017. You requested that the hearing be rescheduled to April 17, 2017 at 9:00 a.m. because you were currently on vacation. Your request to reschedule your hearing was granted by the Hearing Officer.

On April 17, 2017 at 9:00 a.m., the Hearing Officer called you to conduct the hearing. You answered the call and stated that you no longer wished to proceed with the appeal since you believed that your child's eligibility had been fixed, and that you did not want any further potential alterations to her eligibility. The Hearing Officer asked to swear you in to obtain a formal withdrawal. You stated that you still did not want to proceed with the hearing, and to just cancel the appeal.

Since your hearing did not go forward as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate, or cancel, this dismissal. You must ask us, in writing, within 30 of the date on this notice. In that writing, you must explain why your hearing did not go forward as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
