NOTICE OF DISMISSAL – FAILURE TO APPEAR

On November 22, 2016, NYSOH issued a disenrollment notice stating that your [REDACTED] child's Child Health Plus coverage would end November 30, 2016, because they were no longer eligible to enroll in health insurance.

On December 9, 2016, NYSOH issued an enrollment notice confirming, that you were enrolled in a Medicaid Managed Care (MMC) plan with a plan enrollment start date of January 1, 2017.

On January 19, 2017, you spoke with NYSOH's Account Review Unit and requested an appeal because you and your [REDACTED] child were not enrolled in health coverage for the month of December 2016.

On May 2, 2017, a Hearing Officer from the NYSOH Appeals Unit contacted you to conduct the formal hearing. You testified that the issue may have been resolved. The Hearing Officer adjourned the hearing until May 4, 2017 at 12:00 pm to allow you to contact NYSOH to verify that the issue under appeal had been resolved. You waived formal notice of a telephone hearing.

On May 4, 2017, the Hearing Officer from the NYSOH Appeals Unit attempted to contact you using the telephone number that you provided to NYSOH between 12:00 pm and 12:20 pm. However, there was no answer. Accordingly, we were unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NY State of Health will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us in writing within 30 days after the date on this notice. In that writing, explain why you did not appear for your hearing as scheduled.

The NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
