Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health properly determine that you were eligible to receive up to \$0.00 per month in advance payments of the premium tax credit, effective March 1, 2017?

Did NY State of Health properly determine that you were not eligible for cost-sharing reductions?

Procedural History

On January 19, 2017, you updated your NY State of Health (NYSOH) application for financial assistance. That day, a preliminary eligibility determination was prepared stating that you were eligible to receive up to \$0.00 in advance payments of the premium tax credit (APTC) and that you were ineligible for cost-sharing reductions, effective March 1, 2017.

Also on January 19, 2017, you spoke to NY State of Health's Account Review Unit and appealed the determination; in so far, that you were not eligible for a higher level of APTC.

On January 20, 2017, NYSOH issued a notice of eligibility determination, based on the January 19, 2017 application, stating that you were eligible to receive up to \$0.00 in APTC, effective March 1, 2017. The notice also stated that you were ineligible for cost-sharing reductions because your household income was over the allowable limits for that program.

On April 18, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim one dependent on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on January 19, 2017 listed annual household income of \$63,900.00, consisting of \$33,800.00 you earn from your employment and \$30,100.00 your spouse receives for his employment.
- 4) You testified that your husband is employed as a [REDACTED] and his income varies based on the number of client appointments he has.
- 5) Your application states that you will not be taking any deductions on your 2017 tax return. However, you testified that you may take student loan deductions and a tuition and fee deduction on your 2017 tax return, but that you are not sure yet.
- 6) Your application states that you live in [REDACTED]
- 7) You testified that you are seeking a greater amount of financial assistance through this appeal.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll

in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$20,160.00 for a three-person household (81 Fed. Reg. 4036.).

For annual household income in the range of at least 300% but less than 400% of the 2016 FPL, the expected contribution is between 9.69% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for

which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Legal Analysis

The first issue is whether NYSOH properly determined that you were eligible for an APTC of \$0.00 per month.

You testified that your husband's income varies because he is a [REDACTED]. You testified that his income of \$30,100.00 was an estimated annual income amount. You further testified that his income depends on the number of client appointments he has and you are unsure as to what his exact annual income will be.

However, the application that was submitted on January 19, 2017 listed an annual household income of \$63,900.00 which consisted of your spouse's expected annual income of \$30,100.00 and your expected annual income of \$33,800.00 and the eligibility determination relied upon that information.

You are in a three-person household. You expect to file your 2017 income taxes as married filing jointly and will claim one dependent on that tax return. You testified that you may take a student loan deduction, and a tuition and fee deduction on your 2017 tax return, but you are not sure yet. However, your application states that you are planning on taking no deductions on your 2017 tax return and the eligibility determination relied upon that information.

You reside in [REDACTED] where the second lowest cost silver plan available for an individual through NYSOH costs \$471.15 per month.

An annual income of \$63,900.00 is 316.96% of the 2016 FPL for a three-person household. At 316.96% of the FPL, the expected contribution to the cost of the health insurance premium is 9.69% of income, or \$516.00 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual in your county (\$471.15 per month) minus your expected contribution (\$516.00 per month), which equals \$ - 44.84 per month. Therefore, rounding to the nearest dollar, NYSOH correctly determined you to be eligible for up to \$0.00 per month in APTC.

The second issue is whether you were properly found ineligible for cost-sharing reductions.

Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$63,900.00 is

316.96% of the applicable FPL, NYSOH correctly found you to be ineligible for cost sharing reductions.

Since the January 20, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for \$0.00 per month in APTC, and were ineligible for cost-sharing reductions, it is correct and is AFFIRMED.

Decision

The January 20, 2017 eligibility determination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for \$0.00 in APTC.

You are ineligible for cost-sharing reductions.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
