## Issues

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you were not eligible for financial assistance, effective February 1, 2017?

## Procedural History

On January 18, 2017, NYSOH redetermined your eligibility for financial assistance.

On January 19, 2017, NYSOH issued an eligibility redetermination notice stating that you were qualified to purchase a full cost QHP, effective February 1, 2017. The notice stated that you were not eligible for Medicaid, Child Health Plus, the Essential Plan or to receive advance premium tax credits because your income was above the allowable income limits for these programs.

On January 20, 2017, you spoke to NYSOH's Account Review Unit and appealed your eligibility insofar as you were not eligible for financial assistance.

On April 12, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of single. You will claim no dependents on that tax return.
- 2) You are seeking insurance for yourself.
- 3) The application that was submitted on January 18, 2017 listed annual household income of \$137,192.00. This household income was based on your 2015 federal tax return. You testified that this amount was not an accurate representation of your household income for 2017.
- 4) On April 2, 2017, you uploaded a copy of your 2016 income tax return (documents [REDACTED]).
- 5) You testified and your 2016 tax return confirms that your adjusted gross income for 2016 was \$61,312.00.
- 6) Your 2016 tax return includes \$5,397.00 in tax exempt interest.
- 7) You testified that you expected to make slightly less income in 2017 than in 2016.
- 8) Your application states that you live in Kings County.
- 9) You testified that you are seeking to be determined eligible for financial assistance.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## Applicable Law and Regulations

### Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Federal Register 4036).

### Cost-Sharing Reductions

Cost-sharing reductions (CSR) are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

### Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

In an analysis of Essential Plan eligibility, the determination is based on the FPL in effect on the first day of the benefit year for which coverage is requested (45 CFR § 155.300(a)). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

### Medicaid

Medicaid can be provided through NYSOH to adults who: (1) are age 19 or older and under age 65, (2) are not pregnant, (3) are not entitled to or enrolled for Medicare benefits under part A or B of title XVIII of the Act, (4) are not otherwise eligible for and enrolled for mandatory coverage under a State's Medicaid State plan in accordance with subpart B of this part, and (5) have a household modified adjusted gross income (MAGI) that is at or below 138% of the FPL for the applicable family size (42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)), NY Social Services Law § 366(1)(b)).

In an analysis of Medicaid eligibility, the determination is based on the FPL “for the applicable budget period used to determine an individual's eligibility” (42 CFR § 435.4). On the date of your application, that was the 2016 FPL, which is \$11,880.00 for a one-person household (81 Fed. Reg. 4036).

### Modified Adjusted Gross Income

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code (45 CFR § 155.300(a)). The term “modified adjusted gross income” means adjusted gross income increased by (1) any income that was excluded under 26 USC § 911 for United States citizens or residents living abroad, (2) tax-exempt interest received or accrued, and (3) Social Security benefits that were excluded from gross income under 26 USC § 86 (see 26 USC § 36B(d)(2)(B), 26 CFR § 1.36B-1(e)(2)).

“Adjusted gross income” means, in the case of an individual taxpayer, gross federal taxable income minus certain specific deductions, such as expenses reimbursed by an employer, losses from sale or exchange of property, losses from premature withdrawal of funds from time savings accounts, deductions attributable to royalties, and certain retirement savings (26 USC § 62(a)). Living expenses, such as rent and utilities are not an allowable deduction in computing adjusted gross income.

## **Legal Analysis**

The issue is whether NY State of Health (NYSOH) properly determined that you were ineligible for any financial assistance, effective February 1, 2017.

The application dated January 18, 2017 reflected an annual household income of \$137,192.00. This household income was based on your 2015 federal tax return. You testified that this amount was not an accurate representation of your household income for 2017. Prior to the hearing, you uploaded your 2016 federal tax return to your NYSOH account to be used to determine your eligibility for financial assistance.

According to your 2016 tax return, your adjusted gross income for 2016 was \$61,312.00. Your 2016 tax return indicated that you accrued \$5,397.00 in tax exempt interest. You testified that you expect to earn slightly less than that in 2017, but did not provide a specific income.

NYSOH bases its eligibility determinations on modified adjusted gross income as defined in the federal tax code. The term “modified adjusted gross income” means adjusted gross income increased by tax-exempt interest received or accrued. Therefore, this amount (\$5,397.00) would increase your modified gross income to \$66,709.00.

On the date of your application, the relevant FPL was \$11,880.00 for a one-person household. Since \$66,709.00 is 561.52% of the 2016 FPL, based on the available information regarding your most current income, you were not eligible for any financial assistance, which is available only to those with a household income of 400% of the applicable FPL or less.

Since the January 19, 2017 eligibility determination properly stated that you were not eligible for financial assistance from NYSOH, it is correct and is AFFIRMED.

## **Decision**

The January 19, 2017 eligibility determination notice is AFFIRMED.

## **How this Decision Affects Your Eligibility**

You are ineligible for financial assistance from NYSOH.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
