## Issue

The issue presented for review by the Appeals Unit of NY State of Health is

Did NY State of Health (NYSOH) properly determine that you were newly eligible to purchase a qualified health plan at full cost, and not eligible for the Essential Plan, effective February 1, 2017?

## Procedural History

On February 5, 2016, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan, effective March 1, 2016.

On January 6, 2017, NYSOH issued a renewal notice stating that it was time to renew your NYSOH coverage for 2017. The notice stated that you needed to update the information in your NYSOH account by February 15, 2017, or you could lose the financial assistance you were currently receiving.

On January 17, 2017, you updated your NYSOH account.

On January 18, 2017 NYSOH issued a notice of eligibility determination stating that you were newly conditionally eligible to purchase a qualified health plan at full cost, effective February 1, 2017. The notice stated that you were not eligible to receive tax credits toward the cost of your insurance because NYSOH had determined that you were already enrolled in, or eligible for, a public insurance program such as Medicare. The notice further directed you to submit proof of any termination of your Medicare Part A or Part B coverage by March 3, 2017.

Also on January 18, 2017, NYSOH issued a disenrollment notice stating that your Essential Plan 1 coverage would end on January 31, 2017 because you were no longer eligible to enroll in the Essential Plan.

On January 23, 2017, you spoke to NYSOH's Account Review Unit and appealed the January 18, 2017 eligibility determination notice, insofar as you were not found eligible for the Essential Plan. You also requested Aid to Continue pending the outcome of your appeal.

On February 3, 2017, NYSOH issued a notice of eligibility determination stating that you were eligible to enroll in the Essential Plan for a limited time, effective February 1, 2017. This was because your request for Aid to Continue was granted, pending the outcome of your appeal.

Also on February 3, 2017, NYSOH issued a notice of enrollment confirmation, confirming your enrollment in an Essential Plan, effective February 1, 2017. This was a result of your request for Aid to Continue, pending the outcome of your appeal.

On May 26, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

## **Findings of Fact**

A review of the record supports the following findings of fact:

- 1) Your NYSOH account reflects, and your testimony confirmed, that you turned [REDACTED] on [REDACTED].
- 2) You testified that you began receiving Medicare Part A and Part B when you turned [REDACTED].
- 3) Your NYSOH account indicates that on January 17, 2017, your application was updated, and you were found no longer eligible for the Essential Plan as of January 31, 2017.
- 4) You testified that you filed this appeal because you needed your health insurance to continue while you go through the process of applying for help with your Medicare premiums through your local Department of Social Services.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

## **Applicable Law and Regulations**

### Eligibility for the Essential Plan

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated (see 42 CFR § 600.305, 42 CFR § 435.603(d)(4), 45 CFR § 155.305(e), NY Social Services Law § 369-gg(3), 42 USC § 18051).

NYSOH must verify the eligibility of an applicant for the Essential Plan consistent with the standards set in 45 CFR § 155.315 and § 155.320 (New York's Basic Health Plan Blueprint, pgs. 16-17, as approved January 2016; see <https://www.medicaid.gov/basic-health-program/basic-health-program.html>; 42 CFR § 600.345(a)(2)).

## **Legal Analysis**

The issue under review is whether NYSOH properly determined that you were no longer eligible for the Essential Plan, effective February 1, 2017.

NYSOH must generally determine an applicant eligible for the Essential Plan, a basic health plan, if the person is (1) a resident of New York State, (2) expects to have a household income between 138% and 200% of the applicable federal poverty level (FPL) or, in the case of an individual who is a lawfully present non-citizen who is ineligible for Medicaid or Child Health Plus as a result of their immigration status, has a household income that is between 0% and 200% of the FPL, (3) is not otherwise eligible for minimum essential coverage except through the individual market, (4) is 64 years old or younger, (5) is a citizen or a lawfully present non-citizen, and (6) is not incarcerated.

Your NYSOH account reflects, and your testimony confirmed, that you are 65 years old, and that you are eligible for Medicare.

Therefore, since you are not 64 years old or younger, and since you have access to minimum essential coverage in the form of Medicare, you are not eligible for the Essential Plan.

For this reason, the January 18, 2017 eligibility determination notice is AFFIRMED.

## **Decision**

The January 18, 2017 notice of eligibility determination is AFFIRMED.

## **How this Decision Affects Your Eligibility**

NYSOH properly found you ineligible to enroll in the Essential Plan as of February 1, 2017.

## **If You Disagree with this Decision (Appeal Rights)**

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
