## NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On January 18, 2017, NY State of Health (NYSOH) issued a notice of enrollment confirmation, stating that you were enrolled in your Medicaid Managed Care plan, effective February 1, 2017. You appealed that determination.

On April 13, 2017, you were scheduled for a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. You requested that day that the hearing be adjourned to a later date.

On April 28, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself, you waived your right to formal notice of the hearing, and stated that you were no longer interested in pursuing your appeal because your outstanding bill had already been paid and your currently have coverage under a Medicaid Managed Care plan.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).

## **How does this Dismissal Affect Your Eligibility?**

The Appeals Unit of NY State of Health will not be reviewing this matter at this time.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
