NOTICE OF DISMISSAL – TELEPHONE WITHDRAWAL

On January 25, 2017, NY State of Health (NYSOH) issued an enrollment notice stating your child ([REDACTED]) was enrolled in a Child Health Plus plan with a premium amount of \$9.00 per month effective March 1, 2017. You appealed that notice.

On May 5, 2017, a Hearing Officer from the Appeals Unit of NY State of Health called you and placed you under oath.

While under oath, you identified yourself and stated you were no longer interested in pursuing your original appeal because your child was enrolled in a Child Health Plus plan with a premium responsibility of \$9.00 per month back to the date you had requested, February 1, 2017. You testified you were now only interested in receiving an explanation from NYSOH representatives regarding the reason for termination of your youngest child from her Medicaid Managed Care plan for the months of August, September, and October, 2016. You testified you did not believe you needed a formal hearing for the issue and would be interested in speaking with someone who could confirm your child's enrollments for those previous months.

You therefore withdrew your appeal on the record. Accordingly, we are dismissing your appeal, pursuant to 45 Code of Federal Regulations (CFR) § 155.530(a)(1).
