Issues

The issues presented for review by the Appeals Unit of NY State of Health are:

Did NY State of Health (NYSOH) properly determine that you were eligible to receive \$0.00 per month in advance payments of the premium tax credit (APTC), effective March 1, 2017?

Did NYSOH properly determine that you were not eligible for cost-sharing reductions (CSR)?

Procedural History

On January 23, 2017, NYSOH received your completed application for health insurance.

On January 24, 2017, NYSOH issued an eligibility redetermination notice, based on the information contained in the January 23, 2017 application, stating that you were eligible for \$0.00 in APTC and ineligible for CSR, effective March 1, 2017.

On March 10, 2017, you contacted NYSOH's Account Review Unit and requested an appeal of that eligibility determination, insofar as you were eligible for no more than \$0.00 in APTC, effective March 1, 2017.

On May 10, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You testified that you expect to file your 2017 taxes with a tax filing status of married filing jointly. You will claim one dependent on that tax return.
- 2) The application that was submitted on January 23, 2017 listed annual household income of \$69,132.00. You testified that this amount was correct.
- 3) Your application states that you live in Nassau County.
- 4) You testified that you were seeking a redetermination of your eligibility for APTC, effective March 1, 2017.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

Advance Payments of Premium Tax Credit

Advance payments of the premium tax credit (APTC) are generally available to a person who is eligible to enroll in a qualified health plan (QHP) and (1) expects to have a household income between 138% and 400% of the applicable federal poverty level (FPL), (2) expects to file a tax return and claim a personal exemption deduction for a person who meets the eligibility requirements to enroll in a QHP, and (3) is not otherwise eligible for minimum essential coverage except through the individual market (see 45 CFR § 155.305(f), 42 CFR § 435.119(b), 42 CFR § 435.911(b)(1), 42 CFR § 435.603(d)(4)).

The maximum amount of APTC that can be authorized equals:

- 1) the cost of the health insurance premium for the taxpayer's coverage family in the second lowest cost silver plan offered through NY State of Health in the county where the taxpayer resides

minus

- 2) the taxpayer's expected contribution amount

(see 26 USC § 36B, 26 CFR § 1.36B-3).

The taxpayer's expected contribution amount is the amount that the taxpayer is expected to spend on health insurance premiums. The expected contribution for 2017 is set by federal law at 2.04% to 9.69% of household income (26 USC § 36B(b)(3)(A), 26 CFR § 1.36B-3T(g)(1), IRS Rev. Proc.2016-24).

In an analysis of APTC eligibility, the determination is based on the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested (45 CFR §§ 155.300(a), 155.305(f)(1)(i)). On the date of your application, that was the 2016 FPL, which is \$20,160.00 for a three-person household (81 Federal Register 4036).

For annual household income in the range of at least 300% but less than 400% of the 2016 FPL, the expected contribution is 9.69% of the household income (26 CFR § 1.36B-3T(g)(1), 45 CFR § 155.300(a), IRS Rev. Proc. 2014-37, IRS Rev. Proc. 2016-24).

People who use the APTC to help pay health insurance premiums must file a federal tax return and reconcile their expected income (stated on NYSOH application) with their actual income (stated on their federal income tax return). Those who take less tax credit in advance than they claim on the tax return may get the rest of it as an income tax refund or have their tax bill reduced. Those who take more tax credit in advance than they can claim on their tax return will owe the difference as additional income taxes (26 CFR § 1.36B-4).

Cost-Sharing Reductions

Cost-sharing reductions are available to a person who (1) is eligible to enroll in a QHP through NYSOH, (2) meets the requirements to receive APTC, (3) is expected to have an annual household income that does not exceed 250% of the FPL for the first day of the open enrollment period of the benefit year for which coverage is requested, and (4) is enrolled in a silver-level QHP (45 CFR § 155.300(a), 45 CFR § 155.305(g)(1)).

Legal Analysis

The first issue under review is whether NYSOH properly determined that you were eligible for APTC of \$0.00 per month, effective March 1, 2017.

The application that was submitted on January 23, 2017 listed an annual household income of \$69,132.00, and the eligibility determination relied upon that information.

You are in a three-person household. You expect to file your 2017 income taxes as married filing jointly and will claim one dependent on that tax return.

You reside in Nassau County, where the second lowest cost silver plan available for an individual subscriber through NYSOH costs \$385.22 per month.

An annual income of \$69,132.00 is 342.92% of the 2016 FPL for a three-person household. At 342.92% of the FPL, the expected contribution to the cost of the health insurance premium is 9.69% of income, or \$558.24 per month.

The maximum amount of APTC that can be approved equals the cost of the second lowest cost silver plan available through NYSOH for an individual subscriber in your county (\$385.22 per month) minus your expected contribution (\$558.24 per month). Here, your expected contribution exceeds the cost of an individual subscriber plan in your county. Therefore, NYSOH correctly determined you to be eligible for \$0.00 per month in APTC.

The second issue is whether you were properly found ineligible for cost-sharing reductions. Cost-sharing reductions are available to a person who has a household income no greater than 250% of the FPL. Since a household income of \$69,132.00 is 342.92% of the applicable FPL, NYSOH correctly found you to be ineligible for cost sharing reductions.

Since the January 24, 2017 eligibility determination properly stated that, based on the information you provided, you were eligible for \$0.00 per month in APTC and ineligible for cost-sharing reductions, it is correct and is AFFIRMED.

Decision

The January 24, 2017 eligibility redetermination notice is AFFIRMED.

How this Decision Affects Your Eligibility

You remain eligible for \$0.00 in APTC.

You are ineligible for cost-sharing reductions.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.
