Issue

The issue presented for review by the Appeals Unit of NY State of Health is:

Did NY State of Health (NYSOH) properly determine that you do not qualify to enroll in a qualified health plan outside of the open enrollment period, as of February 15, 2017?

Procedural History

On December 9, 2016, NYSOH issued an eligibility determination notice, based on your December 8, 2016 application, stating that you were eligible to receive an advance premium tax credit of up to \$326.00 per month, effective January 1, 2017.

Also on December 9, 2016, NYSOH issued a plan enrollment notice, based on your December 8, 2016 plan selection, confirming you were enrolled in a qualified health plan with a monthly premium of \$311.00 per month, effective January 1, 2017.

On January 12, 2017, NYSOH issued an eligibility determination notice, based on your January 11, 2017 updated application, stating that you were eligible to receive an advance premium tax credit of up to \$326.00 per month, effective February 1, 2017.

On January 20, 2017, NYSOH issued a plan enrollment notice, based on your January 19, 2017 updated plan selection, confirming you were enrolled in a qualified health plan, effective January 1, 2017.

On January 25, 2017, you spoke to NYSOH's Account Review Unit and appealed that eligibility determination insofar as your enrollment in your qualified health plan was effective January 1, 2017 and not February 1, 2017.

On April 19, 2017, you had a telephone hearing with a Hearing Officer from NYSOH's Appeals Unit. Your request to amend the appeal to request a special enrollment period was granted and testimony on that issue was received. The record was developed during the hearing and closed at the end of the hearing.

Findings of Fact

A review of the record supports the following findings of fact:

- 1) You were enrolled in a qualified health plan for the 2017 coverage year with a monthly premium of \$311.00, effective January 1, 2017.
- 2) You testified that, in February 2017, you attempted to pay your health plan and they refused to accept your premium payment. They also would not allow you to enroll in coverage due to your failure to pay your October 2016 and November 2016 premium payments.
- 3) You testified that, at some point near the end of February 2017, you realized that you should just change health plans. You contacted NYSOH and requested to do so and a NYSOH representative told you that it was past the open enrollment period and would not allow you to attempt to enroll in a different health plan.
- 4) Your record reflects that a call was made to NYSOH by you on February 15, 2017 discussing the fact that your health plan would not accept your premium payment.
- 5) You testified that you have been without health insurance since October 2016.
- 6) You testified that since filing your application on December 8, 2016 and spoke with a NYSOH representative on February 15, 2017, there have been no major changes to your household.

Conflicting evidence, if any, was considered and found to be less credible than the evidence noted above.

Applicable Law and Regulations

De Novo Review

NYSOH Appeals Unit must review each appeal de novo and "consider all relevant facts and evidence adduced during the appeals process" (45 CFR § 155.535(f)). "De novo review means a review of an appeal without deference to prior decisions in the case" (45 CFR § 155.500).

Enrollment in a Qualified Health Plan

NYSOH must provide annual open enrollment periods during which time qualified individuals may enroll in a qualified health plan and enrollees may change qualified health plans (45 CFR § 155.410(a)(1)).

For the benefit year beginning on January 1, 2017, the annual open enrollment period began on November 1, 2016, and extended through January 31, 2017 (45 CFR § 155.410(e)(2)).

Special Enrollment Periods

After each open enrollment period ends, NYSOH provides special enrollment periods to qualified individuals. During a special enrollment period, a qualified individual may enroll in a qualified health plan, and an enrollee may change their enrollment to another plan. This is generally permitted when one of the following triggering events occur:

- (1) The qualified individual or his or her dependent either:
 - (i) Loses minimum essential coverage.
 - (ii) Is enrolled in any non-calendar year group health plan or individual health insurance coverage, even if the qualified individual or his or her dependent has the option to renew such coverage.
 - (iii) Loses pregnancy-related coverage.
 - (iv) Loses medically needy coverage as described under section 1902(a)(10)(C) of the Social Security Act only once per calendar year.

Generally, if a triggering life event occurs, the qualified individual or enrollee has 60 days from the date of a triggering event to select a qualified health plan (45 CFR § 155.420(c)(1)).

However, a loss of health insurance coverage such as that referenced above does not include,

"voluntary termination of coverage or other loss due to—

- (1) Failure to pay premiums on a timely basis, including COBRA premiums prior to expiration of COBRA coverage, or
- (2) Situations allowing for a rescission as specified in 45 CFR [§] 147.128" such as failure to comply with other requirements (45 CFR § 147.128(b))

(45 CFR § 155.420(e)).

Legal Analysis

The issue under review is whether NYSOH properly determined that, as of February 15, 2017, you did not qualify to enroll in a qualified health plan outside of the open enrollment period.

You testified that you are appealing the denial of a special enrollment period to allow you to enroll into a health plan through NYSOH. However, the record does not contain a notice of eligibility determination or redetermination on the issue of special enrollment period.

Here, the lack of a notice of eligibility determination on the issue of special enrollment periods does not prevent the Appeals Unit from reaching the merits of the case or constitute material error. Under 45 CFR § 155.505(b), you are as entitled to appeal NYSOH failure to timely issue a notice of eligibility determination as you are to appeal an adverse notice of eligibility determination. Your credible testimony, along with the February 15, 2017 telephone record, permits an inference that NYSOH did deny your special enrollment request.

Since the Appeals Unit review of NYSOH determinations is performed on a de novo basis, no deference would have been granted to the eligibility determination notice had it been issued.

NYSOH provided an open enrollment period from November 1, 2016 until January 31, 2017. On February 15, 2017, after the open enrollment period ended, you requested to enroll in a qualified health plan but were told by a NYSOH representative that it was past the open enrollment period and were verbally denied that request.

Once the annual open enrollment period ends, a health plan enrollee must qualify for a special enrollment period to enroll in, or change to another health

plan offered in NYSOH. To qualify for a special enrollment period, a person must experience a triggering event.

In the present case, there is no evidence in the record to establish grounds for a special enrollment period. You testified that there have been no changes to your household in 2017.

Further, you testified that you have not had health insurance since October 2016, which was a result of your failure to pay the health plan the monthly premiums for October 2016 and November 2016. The loss of health insurance coverage in this case cannot be considered a triggering event for a special enrollment period because it was a result of non-payment of your premiums, which NYSOH considers a voluntary action causing the termination of your coverage.

The credible evidence of record indicates that, since the open enrollment period closed on January 31, 2017, no other triggering events have occurred that would qualify you for a special enrollment period.

Therefore, NYSOH's denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

Decision

NYSOH's denial of a special enrollment period to select a health plan outside of the open enrollment period for 2017 is AFFIRMED.

How this Decision Affects Your Eligibility

You do not qualify for a special enrollment period.

If You Disagree with this Decision (Appeal Rights)

This Decision is final unless you submit an appeal request to the Federal Marketplace or bring a lawsuit under New York Civil Practice Law and Rules, Article 78.

You may bring a lawsuit on any Appeals Unit decision in New York State court in accordance with Article 78 of the New York Civil Practice Law and Rules. This must be done within four months of the Decision Date, which appears on the first page of this Decision.

Additionally, Appeals Unit decisions on issues involving eligibility for qualified health plans, advance premium tax credits, and cost-sharing reductions may be appealed to the Federal Marketplace. This must be done within 30 days of the Decision Date, which appears on the first page of this Decision (45 CFR § 155.520(c)).
