NOTICE OF DISMISSAL – FAILURE TO APPEAR

On January 26, 2017, NY State of Health (NYSOH) issued a notice of eligibility determination, stating that you were eligible to receive up to \$0.00 per month of advance payments of the premium tax credit and to enroll in a qualified health plan, effective March 1, 2017. The notice stated the determination was based on the condition that you provide additional information to confirm your eligibility by providing proof of Income and Citizenship Status by April 20, 2017. You appealed this determination.

On March 20, 2017, NYSOH issued a Notice of Hearing to advise you that the hearing you requested was scheduled for April 20, 2017, at 2:00 p.m.

On April 20, 2017, a Hearing Officer called you and placed you under oath. While under oath you testified, you were unable to proceed with your hearing as you were at work and would have to be back within 15 minutes. The Hearing Officer granted you an adjournment to April 28, 2017, at 4:00 p.m.

On April 28, 2017, a Hearing Officer placed three calls to the telephone number that you provided to NYSOH, at 4:00 p.m., 4:10 p.m., and 4:15 p.m., but was unable to reach you.

Since you did not appear for your hearing as scheduled, we are dismissing your appeal.

How does this Dismissal Affect My Eligibility?

The Appeals Unit of NYSOH will not review your appeal at this time.

If You Think Your Appeal Should Not Be Dismissed

If you think your appeal should not be dismissed, you can ask us to vacate (cancel) this dismissal. You must ask us, in writing, within 30 days after the date on this notice. In that writing, you must explain why you did not appear for your hearing as scheduled.

NYSOH's Appeals Unit will review your request. If your request is approved, another hearing will be scheduled for you. If your request is denied, NYSOH will tell you in writing.

If you do not respond to this notice within 30 days, your appeal will remain dismissed, and NYSOH will take no further action on your appeal.
